- (1) Saskatchewan records problem gambling treatment information by fiscal year. In the fiscal year 2000/01, 15 clients approved for funding by Saskatchewan Health attended the Walter A. "Slim" Thorpe Recovery Centre in Lloydminster for inpatient problem gambling treatment.
- (2) The cost to Saskatchewan Health for treatment of these clients was \$13,500.
- Ms. Draude asked the Government Question No. 489 which was answered by the Hon. Mr. Nilson:

To the Minister of Health: (1) In the year 2001, how many patients were sent to Slim Thorpe Detox Centre in Lloydminster for treatment of gambling addictions? (2) What was the cost for treatment of these patients?

The criteria used by the Regina Qu'Appelle Regional Health Authority to award contracts to private physiotherapy clinics are:

- 1. Qualifications of professional staff
- 2. Supervision of unlicensed personnel
- 3. Staff identification
- 4. Continuing competency
- 5. Planned orientation for professional and support staff
- 6. Written documentation/care plan/client intervention
- 7. Scheduling
- 8. Adequate physical space for safe movement/treatment delivery
- 9. Equipment maintenance/safety
- 10. Safety procedures and policies
- 11. Infection control policies/procedures
- 12. Insurance coverage: liability/malpractice
- 13. Outcome reporting
- 14. Statistical reporting
- 15. Number of years clinic in operation
- 16. Clinic demographics
- 17. Previous contracts with the Region
