- (2) Hodgeville, Yellow Grass, Abernethy, Fort San, Katepwa, Lipton, Lemburg, Neudorf, Lebret, Codette, Govan, Stewart Valley, Macoun, Frobisher, Hafford, Mankota, Yorkton and Candle Lake. Typically, residents within an approximate radius of 30 kilometres of an internet-provisioned tower may be able to access the service, but this is a wireless signal and is dependent upon terrain.
