That the motion be amended by deleting all the words after "on the" and the following substituted therefor:

"provincial government to take the necessary steps to ensure that all harassment complaints are treated seriously, regardless of who they are alleged against, that due process be followed, and that women who bring complaints forward are not further victimized by the department's actions or lack thereof."

The Acting Speaker ruled that the amendment was out of order on the grounds that it was irrelevant to the main motion.

The debate continuing on the motion and the period of seventy-five minutes having expired, pursuant to Rule 22(5), the Speaker interrupted proceedings.
