### **QUESTIONS AND ANSWERS**

## Mr. Merriman asked the Government the following Question No. 540, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: When will the Oyate Safe House be receiving new residents?

Answer:

The plan is to open the Oyate transitional care services to new placements in June.

## Mr. Merriman asked the Government the following Question No. 541, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: What is the cost of the recently announced foster families recruitment campaign?

Answer:

The cost of the recently announced campaign is \$93,132.

## Mr. Merriman asked the Government the following Question No. 542, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: How many new foster families were recruited in the 2006/07 fiscal year?

Answer:

77

## Mr. Merriman asked the Government the following Question No. 543, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: How many foster families were lost during the 2006/07 fiscal year?

# Mr. Merriman asked the Government the following Question No. 544, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: What is the net number of foster families for the 2006/07 fiscal year?

Answer:

There was a net increase of 48, bringing the total number of foster families to 799.

### Mr. Morgan asked the Government the following Question No. 545, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: How much of the payment to Murdoch Carriere was for general damages?

Answer:

The payment was negotiated as a global settlement of all legal proceedings without attributing values to the specific claims advanced by Murdoch Carriere, including general damages, past loss of income, pay in lieu of notice, loss of benefits, damages for defamation, misfeasance in public office, negligence and disclosure of personal information, aggravated and punitive damages, pre-judgment interest and costs.

For reasons related to the payment of tax, Mr. Carriere wanted the settlement agreement to stipulate that no portion of the payment was to be attributed to pay in lieu of notice. It was the government's position that this may not fairly represent the settlement and may mislead the Canada Revenue Agency. Since this was a matter that would ultimately be determined by the Canada Revenue Agency and did not bear on the settlement itself, the parties agreed to simply state their respective positions.

Therefore, the settlement agreement records Mr. Carriere's position that the amount does not include pay in lieu of notice, and the government's position is recorded as follows: "Settlement Amount includes 16 months of pay in lieu of notice, that is \$120,048 plus defendant contributions on account of pension at the rate of 6.25% (\$7503)". The figure of \$120,048 represents the minimum amount the government was prepared to assign to the category of pay in lieu of notice.

### Mr. Morgan asked the Government the following Question No. 546, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: How much of the payment to Murdoch Carriere was regarded taxable income?

#### Answer:

The parties could not agree on the tax consequences of the settlement. That issue will be resolved between Murdoch Carriere and the Canada Revenue Agency, subject to any right of appeal to the courts.

### Mr. Morgan asked the Government the following Question No. 547, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: How much of the payment to Murdoch Carriere was paid as taxable costs?

#### Answer:

This question is answered in the response to question 545.

## Mr. Morgan asked the Government the following Question No. 548, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: In the settlement with Murdoch Carriere, which party asked for non-disclosure?

#### Answer

The government's position throughout negotiations was that it would not agree to a non-disclosure provision and none is contained in the settlement with Mr. Carriere.

### Mr. Morgan asked the Government the following Question No. 549, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: Was the Carriere settlement made *ex gratia*, or was it made with an admission of liability or guilt on behalf of the government?

#### Answer:

The Carriere settlement was paid on a legal opinion provided by Justice. The release contained the usual terms denying liability.

### Mr. Morgan asked the Government the following Question No. 550, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: How much of the payment to Murdoch Carriere was pay in lieu of notice?

#### Answer

This question is answered in the response to question 545.

### Mr. Morgan asked the Government the following Question No. 551, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: On what date was this settlement signed personally by Mr. Carriere?

#### Answer:

The release signed by Mr. Carriere is dated February 9, 2007 and was delivered to the government on February 22, 2007.

### Mr. Morgan asked the Government the following Question No. 552, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: What was the negotiated amount and the date of the cheque that was sent to Mr. Carriere's solicitor?

### Answer:

\$275,000 was the negotiated settlement. The cheque was sent to Mr. Carriere's solicitor on January 26, 2007.

### Mr. Morgan asked the Government the following Question No. 553, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: On what date were the minutes and settlement releases for the Murdoch Carriere settlement signed?

#### Answer:

"Short form minutes of settlement and indemnification agreement and release" were signed on January 9, 2007, and were subject to the drafting of a final release signed by Mr. Carriere and dated February 9, 2007. Subsequent to January 9th, there were telephone conversations and correspondence exchanged between the lawyers about the tax issue. That delayed delivery of the final documents.

### Mr. Morgan asked the Government the following Question No. 554, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: On what date were the funds sent to Mr. Carriere's lawyer?

### Answer:

The cheque was sent to Mr. Carriere's lawyer on January 26, 2007, subject to trust conditions for the delivery of the final release and the completion of steps to conclude legal proceedings.

### Mr. Morgan asked the Government the following Question No. 555, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: On what date was the Murdoch Carriere settlement agreed to?

#### Answer:

The terms of settlement were concluded on January 9, 2007. The settlement was finalized when the release signed by Mr. Carriere was delivered to the government on February 22, along with confirmation that Mr. Carriere had discontinued the court action and abandoned his appeal to the Public Service Commissioners.

### Mr. Morgan asked the Government the following Question No. 556, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: On what date was this settlement signed by the government?

#### Answer:

The short form Minutes of Settlement were signed on January 9, 2007.

## Mr. Morgan asked the Government the following Question No. 557, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for the Public Service Commission: What was the date recorded on the cheque given to Murdoch Carriere as settlement with the government?

#### Answer:

The date recorded on the cheque was January 26, 2007.

To the Minister of Environment: (1) How many prosecutions and penalties were made under *The Environmental Management and Protection Act*, 2002 in the fiscal year 2002/03? (2) What were the offences and the penalties for each offence?

#### Answer:

- (1) No prosecutions, no penalties.
- (2) N/A

### Mr. Hart asked the Government the following Question No. 559, which was answered by the Hon. Mr. Nilson:

To the Minister of Environment: (1) How many prosecutions and penalties were made under *The Environmental Management and Protection Act*, 2002 in the fiscal year 2003/04? (2) What were the offences and the penalties for each offence?

#### Answer:

- (1) One prosecution, one penalty.
- (2) Unauthorized shoreline alteration, penalty of \$500.

### Mr. Hart asked the Government the following Question No. 560, which was answered by the Hon. Mr. Nilson:

To the Minister of Environment: (1) How many prosecutions and penalties were made under *The Environmental Management and Protection Act*, 2002 in the fiscal year 2004/05? (2) What were the offences and the penalties for each offence?

### Answer:

- (1) 13 prosecutions initiated or completed, five penalties.
- (2) Remove and displace material from the bank of a waterbody, penalty of \$9,000.

Alter the configuration of a waterbody, penalty of \$9,000.

Remove vegetation from bank of a waterbody, withdrawn, no penalty.

Failure to comply with a waterworks operational permit, still before the court.

Failure to continuously disinfect human consumptive water, still before the court.

Provide false statement to the Department of Environment, still before the court.

Failure to comply with a waterworks protection order, still before the court.

Provide false operational records and logs for a waterworks, penalty of \$150.

Improper record keeping at waterworks, charge withdrawn.

Operate a waterworks in contravention of a waterworks permit, charge withdrawn.

Alter the bank of a lake without a permit, penalty of \$5,000.

Remove aquatic vegetation from shoreline of fish-bearing waters, penalty of \$875.

Alter the configuration of a bank of a lake, charge withdrawn.

To the Minister of Environment: (1) How many prosecutions and penalties were made under *The Environmental Management and Protection Act*, 2002 in the fiscal year 2005/06? (2) What were the offences and the penalties for each offence?

#### Answer:

- (1) Two prosecutions initiated or completed, one penalty.
- (2) Failure to comply with terms and conditions of a liquid waste hauler permit, penalty of \$550. Failure to comply with a provision of *The Municipal Refuse Management Regulations*, charge withdrawn.

### Mr. Hart asked the Government the following Question No. 562, which was answered by the Hon. Mr. Nilson:

To the Minister of Environment: (1) How many prosecutions and penalties were made under *The Environmental Management and Protection Act*, 2002 in the fiscal year 2006/07? (2) What were the offences and the penalties for each offence?

#### Answer:

- (1) Seven prosecutions initiated or completed, three penalties.
- (2) Provide false information to the Department of Environment, no penalty, completed through alternative measures.
