QUESTIONS AND ANSWERS

Mr. Morgan asked the Government the following Question No. 1317, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: (1) In the 2007/08 budget, how much money is allocated to fighting internet crimes involving children and to cracking down on child pornography? (2) Of the total allotment, where is the money being targeted, and in what amounts?

Answer:

- (1) \$250,000
- (2) The funding provides \$210,000 for two provincial positions with the RCMP Technological Crimes Unit and \$40,000 for specialized software and equipment for that unit.

Mr. Brkich asked the Government the following Question No. 1318, which was answered by the Hon. Mr. Lautermilch:

To the Minister of Highways and Transportation: (1) Has the department assessed the damage to Highway 15? (2) If so, when will the highway be re-opened? (3) What will be the projected cost of repair?

Answer:

- (1) The department has assessed the damage on Highway 15 and has tendered the repair work.
- (2) Highway 15 will re-open when the repairs are completed to a level that ensures safety of the driving public and protection of the existing infrastructure. The department has tendered the project and hopes to proceed with repairs as soon as water levels subside and discontinue overtopping the road.
- (3) The department's pre-tender estimate is \$135,000 to \$155,000.

The Gradworks Board of Directors, in consultation with CIC, determined that it would be more efficient and cost-effective to run Gradworks operations out of CIC using existing staff and resources. CIC estimates that it will save about \$135,000 annually as a result of the transfer.
