To the Minister Responsible for Saskatchewan Telecommunications: Who conducted the analysis of current SaskTel service equipment to support the decision to contract out Operator Services?

Ms. Higgins, to ask the Government the following Question No. 1543:

To the Minister Responsible for Saskatchewan Telecommunications: (1) What was the projected cost to achieve the CRTC requirements for IP operator-based service? (2) What plans have been put in place to provide comparable service to Saskatchewan residents?

Ms. Higgins, to ask the Government the following Question No. 1544:

To the Minister Responsible for Saskatchewan Telecommunications: With regard to the contracting out of Operator Services, what contracts have been signed to provide service?

Ms. Higgins, to ask the Government the following Question No. 1545:

To the Minister Responsible for Saskatchewan Telecommunications: With regard to the contracting out of Operator Services, what contracts are currently in the discussion stage?

Ms. Higgins, to ask the Government the following Question No. 1546:

To the Minister Responsible for Saskatchewan Telecommunications: (1) With regard to the contracting out of Operator Services, with which companies has SaskTel signed contracts? (2) What service is covered by each contract? (3) For what term are the contracts signed?

Ms. Higgins, to ask the Government the following Question No. 1547:

To the Minister Responsible for Saskatchewan Telecommunications: How many employees have lost jobs because of the contracting out of services?

Ms. Higgins, to ask the Government the following Question No. 1548:

To the Minister Responsible for Saskatchewan Telecommunications: How many employees have been offered retraining to fill other positions?

Ms. Higgins, to ask the Government the following Question No. 1549:

To the Minister Responsible for Saskatchewan Telecommunications: What was the total cost of retraining employees displaced by contracting out of services in order to fill other positions?

Ms. Higgins, to ask the Government the following Question No. 1550:

To the Minister Responsible for Saskatchewan Telecommunications: How many employees displaced by contracting out of services have moved to new positions without retraining?
