A debate arising, it was moved by Ms. Wilson, in amendment thereto:

That all the words after the word "Assembly" be deleted and the following added thereto:

"praise the Saskatchewan Party government for its unprecedented management of our provincial finances."

The Speaker ruled the amendment out of order on the grounds that it substantially changed the proposition of the original motion.

The debate continuing and the period of seventy-five minutes having expired, pursuant to Rule 24(4) the Speaker interrupted proceedings.

The Speaker corrected the record and ruled the amendment was in order.

QUESTIONS AND ANSWERS

Mr. Wotherspoon asked the Government the following Question No. 104, which was answered by the Hon. Mr. Krawetz:

To the Minister of Finance: (1) What was the percent increase or decrease of both real and nominal GDP, include the source of these statistics, for the years 2007? (2) 2008? (3) 2009? (4) 2010? Answer:

According to revised figures released on November 4, 2010 by Statistics Canada, Saskatchewan real GDP increased by 3.6 percent in 2007 and 4.6 percent in 2008. It decreased by 3.9 percent in 2009. As well, Saskatchewan nominal GDP increased by 11.5 percent in 2007 and 28.6 percent in 2008. It decreased by 13.6 percent in 2009. Actual data for 2010 are not yet available.

Mr. Wotherspoon asked the Government the following Question No. 106, which was answered by the Hon. Mr. Krawetz:

To the Minister of Finance: What is the annual budgetary impact – based on the most current information and with respect to our current trade climate – for a one cent differential on the Canadian Dollar, on an annual basis, from the projected budgeted value?

To the Minister of Finance: What is the annual budgetary impact – based on the most current information and with respect to our current trade climate – for a one cent differential on the Canadian Dollar, on an annual basis, from the projected budgeted value – on potash revenues alone?

At first quarter, a one US cent change in the fiscal year average value of the Canadian dollar was estimated to result in a \$5 million change in potash revenue, all else equal.

Mr. Wotherspoon asked the Government the following Question No. 109, which was answered by the Hon. Mr. Krawetz:

To the Minister of Finance: What is the annual budgetary impact – based on the most current information and with respect to our current trade climate – for a one dollar differential on the price of a barrel of oil, on an annual basis, from the projected budgeted value?

Answer:

At first quarter, a US\$1 per barrel change in the annual WTI oil price was estimated to result in a \$17.9 million change in oil revenue, all else equal.

Mr. Wotherspoon asked the Government the following Question No. 110, which was answered by the Hon. Mr. Krawetz:

To the Minister of Finance: What amounts of money have been transferred from CIC to and from the GRF since November 7, 2007? (state the date, the amount, the purpose, and whether it is being transferred to or from the GRF)

Answer:

From 2007/08 to the first quarter of 2010/11, CIC has transferred monies to the GRF in the form of regular dividends, special dividends and equity repayments. In 2008/09, the GRF transferred \$240 million in federal funding to CIC for carbon capture funding. The following table summarizes these transfers between CIC and the GRF from 2007/08 to the first quarter of 2010/11.
