QUESTIONS AND ANSWERS

Ms. Junor asked the Government the following Question No. 375, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many acute care beds are scheduled to or have been closed in 2010 because of health region budget restraints? Provide a breakdown for each health region.

Answer:

There have been no acute care beds closed or scheduled for closure in 2010 due to health region budgeting.

Ms. Junor asked the Government the following Question No. 376, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many long-term care beds are scheduled to close or have been closed in 2010 because of health region budget restraints? Provide a break down for each health region.

Answer:

There was a reduction of 60 beds in special-care homes in 2010.

Sun Country Health Region believes that the closure of 5 long-term care beds in Wawota will improve patient safety. The Region also closed 10 long-term care beds in Carlyle as these beds were not in operation for the past 5 years. Sunrise Health Region is converting double rooms to single rooms which will result in a reduction of 45 beds. Many residents prefer a room of their own and this change will improve the quality of care for those residents.

Note: As a pilot project, the ministry through Prince Albert Parkland Regional Health Authority funded 15 long-term care beds in a 30 bed personal care home at Muskeg Lake. The operator of the home chose to close the personal care home and therefore these beds are no longer available.

Ms. Junor asked the Government the following Question No. 377, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many FTE positions have been lost in 2010 because of health region budget restraints? Provide a breakdown for each health region.

Answer:

A total of 135.69 FTE positions have been reduced in 2010 as part of health region budgeting. However, not all reductions resulted in job loss as position bumping continues. The following Regions implemented FTE reductions:

Ms. Junor asked the Government the following Question No. 378, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What is the targeted reduction in spending for each health region in 2010 as a result of the provincial budget?

Answer:

In 2010, there was a total targeted reduction of \$35M for Regional Health Authorities, including the Saskatchewan Cancer Agency and the Athabasca Health Authority. The \$35M was allocated to each Region as follows:

Answer:

There were 52 licensed paediatricians in Saskatoon as of September 2010.

Ms. Junor asked the Government the following Question No. 390, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many MRI technician vacancies are there in each facility in each health region?

Answer:

As of October 28, 2010, the Health Careers in Saskatchewan website identified the following 3 MRI technician vacancies:

• Saskatoon HR - Royal University, City, and St. Paul's Hospitals.

Ms. Junor asked the Government the following Question No. 391, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What are the hours of operation for MRIs in each facility in each health region?

Answer:

MRI services are available at the following hospitals: Regina General Hospital (Regina Qu'Appelle Health Region), Royal University Hospital, Saskatoon City Hospital, St. Paul's Hospital (Saskatoon Health Region) and Lloydminster Hospital (Prairie North Health Region). Regina operates both MRI at the General Hospital from 06:30 to 22:30 Monday through Friday and one of the two units from 06:30 to 15:00 on weekends and Stat. Holidays. On call services are available after hours. In Saskatoon, the Royal University Hospital operates its MRI from 07:30 to 24:00 Monday through Friday, from 8:00 to 16:00 on weekends and from 09:30 to 20:00 on bankdays (occurs every third Friday). On call services are available after hours. Saskatoon City Hospital's MRI operates from 07:30 to 19:00 Monday through Friday. St. Paul's Hospital MRI operates from 07:30 to 24:00 Monday through Friday. On call services are available after hours. In Prairie North Health Region, a mobile MRI unit is being operated in conjunction with the Alberta Health Services Board which visits the Lloydminster Hospital one in every five weeks for four ten-hour days. This service cares for both Alberta and Saskatchewan residents in the area.

Ms. Junor asked the Government the following Question No. 392, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many CT scan technician vacancies are there in each facility in each health region?

Answer:

As of October 28, 2010, the Health Careers in Saskatchewan website identifies the following single medical imaging technologist vacancy:

• Saskatoon HR – no specific facility identified, only the medical imaging department.

Ms. Junor asked the Government the following Question No. 393, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What are the hours of operation for CT scans in each facility in each health region?

Answer:

CT scans are provided in Regional and Provincial Hospitals. Cypress Regional Health Authority -Swift Current's Cypress Regional Hospital operate its CT service from 7:30 to 16:00, Monday through Friday. On-call services are available on weekends and after hours. Five Hills Regional Health Authority – Moose Jaw Union Hospital operates its CT from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours. PA Parkland Regional Health Authority – Victoria Hospital at Prince Albert operates its CT from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours. Prairie North Regional Health Authority - both Battleford Union Hospital and the Lloydminster Hospital operate their CT services from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours. Regina Qu'Appelle Regional Health Authority – The Regina General Hospital operates one of its two CT from 7:00 to 21:00 Monday through Friday and 07:30 to 21:00 on weekends and Stat. Holidays. The second unit operates between 7:00 and 17:00. From 17:00 to 0:00 the scanner is reserved for the Emergency Department and inpatients, Monday through Friday. The Pasqua Hospital operates its CT from 07:00 to 00:30 Monday through Friday and 07:30 to 00:30 on weekends and Stat. Holidays. On call services are available after hours at both Regina hospitals. Saskatoon Regional Health Authority – the Royal University Hospital operates one of its two CT from 07:30 to 20:30 Monday through Friday and from 8:00 to midnight on weekends and stat. Holidays. The

second CT operates from 08:00 to 16:00. On call services are available after hours. Saskatoon City Hospital CT operates between 07:30 and 16:30 Monday through Friday. On call services are available after hours. St. Paul's Hospital CT operates from 07:30 to 17:00 Monday through Friday and on Stat Holidays. On call services are available after hours. Sunrise Regional Health Authority – operates its CT services from 08:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours.

Ms. Junor asked the Government the following Question No. 394, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many laboratory technician vacancies are there in each health region?

Answer:

As of October 28, 2010, the Health Careers in Saskatchewan website identified the following 11 medical laboratory technologist vacancies:

Saskatoon – 1 Prairie North – 2 Kelsey Trail – 4 Sun Country – 2 Sunrise – 2

Ms. Junor asked the Government the following Question No. 395, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of maintenance services in each health region?

Answer:

Three communities experienced a slight reduction in maintenance hours as a result of staffing models being aligned to other regional facilities and standards. However, there has been no reduction in maintenance service for these communities.

Ms. Junor asked the Government the following Question No. 396, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of x-ray services in each health region?

Answer:

Seven communities are experiencing a reduction in hours and three are experiencing an interruption of service as a result of staffing issues and service realignment. The following communities were affected:

Saskatoon Regional Health Authority:

• Wadena – temporary disruption in service.

Prince Albert Parkland Regional Health Authority:

- Hafford & Leoville interruption of service due to service realignment.
- Spiritwood & Big River reduction in hours due to service realignment. Prairie North Health Region:

• Neilburg & Paradise Hill – reduction in hours due to service realignment. Cypress Health Region:

• Eastend – reduction in hours due to staffing.

Five Hills Health Region:

- Central Butte reduction in hours due to staffing.
- Kincaid interruption of service due to staffing.

Ms. Junor asked the Government the following Question No. 397, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of lab services in each health region?

Answer:

Ten communities are experiencing a reduction in hours of lab services as a result of service realignment and staffing issues in the following health regions:

4 – Prince Albert Parkland Regional Health Authority

- 2 Prairie North Health Region
- 1 Cypress Health Region
- 2-Five Hills Health Region
- 1 Sunrise Regional Health Authority

Ms. Junor asked the Government the following Question No. 398, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of dietary services in each health region?

Answer:

One community in the Saskatoon Health Region has reduced dietary service hours due to limited demand, and also eliminated non-essential dietary services (in-house catering for meetings).

Ms. Junor asked the Government the following Question No. 399, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of housekeeping services in each health region?

Answer:

There are no communities experiencing a reduction in hours or a loss of housekeeping services.

Ms. Junor asked the Government the following Question No. 400, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many communities are experiencing a reduction in hours or a loss of ambulance services in each health region?

Answer:

Prairie North Health Region: One community is experiencing a reduction in hours.

Regina Qu'Appelle Health Region: One community is experiencing a reduction in hours.

Cypress Health Region: One community is experiencing a reduction in hours.

Heartland Health Region: Two communities are experiencing a reduction in hours.

Saskatoon Health Region: Two communities are experiencing an interruption of ambulance services.

Ms. Junor asked the Government the following Question No. 401, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What were the Workers' Compensation Board costs for affiliates in 2009? Answer:

The Worker's Compensation Board costs for affiliates in 2009 were \$3,158,405.

To the Minister of Health: What were the Workers' Compensation Board costs for affiliates in 2008? Answer:

The Worker's Compensation Board costs for affiliates in 2008 were \$3,454,108.93.
