Ms. Junor asked the Government the following Question No. 978, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What are the operating hours of CT scanners in each facility in the province?

Answer:

CT scans are provided in regional and provincial hospitals.

Cypress Regional Health Authority – Swift Current's Cypress Regional Hospital operates its CT service from 7:30 to 16:00, Monday through Friday. On-call services are available on weekends and after hours.

Five Hills Regional Health Authority – Moose Jaw Union Hospital operates its CT from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours.

PA Parkland Regional Health Authority – Victoria Hospital at Prince Albert operates its CT from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours.

Prairie North Regional Health Authority – both Battleford Union Hospital and the Lloydminster Hospital operate their CT services from 8:00 to 16:30, Monday through Friday. On-call services are available on weekends and after hours.

Regina Qu'Appelle Regional Health Authority – The Regina General Hospital operates one of its two CTs from 7:00 to 23:00 daily. The second unit operates between 7:00 and 17:00. The Pasqua Hospital operates its CT from 7:00 to 00:30 (12:30am) daily. On call services are available after hours at both Regina hospitals.

Saskatoon Regional Health Authority – the Royal University Hospital operates one of its two CTs from 7:30 to 00:30 (12:30am) Monday through Friday and from 8:00 to 24:00 on weekends and statutory holidays. The second CT operates from 8:00 to 16:00. On call services are available after hours. Saskatoon City Hospital CT operates between 7:30 and 17:30 Monday through Friday. On call services are available after hours. St. Paul's Hospital CT operates from 7:30 to 24:00 Monday through Sunday and on statutory holidays. On call services are available after hours.

Sunrise Regional Health Authority – operates its CT services from 8:00 to 16:30, Monday through Friday. On call services are available on weekends and after hours.

Ms. Junor asked the Government the following Question No. 979, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What are the operating hours of MRI scanners in each facility in the province?

Answer:

MRI services are available at the following hospitals: Regina General Hospital (Regina Qu'Appelle Health Region), Royal University Hospital, Saskatoon City Hospital, St. Paul's Hospital (Saskatoon Health Region) and Lloydminster Hospital (Prairie North Health Region).

Regina operates both MRIs at the General Hospital from 6:30 to 22:30 Monday through Friday and from 7:00 to 15:00 on weekends and statutory holidays. On call services are available after hours.

In Saskatoon, the Royal University Hospital operates its MRI from 7:30 to 00:30 Monday through Friday, from 8:00 to 16:00 on weekends and from 8:00 to 24:00 on bank days (similar to EDOs that occur every third Friday). On call services are available after hours. Saskatoon City Hospital's MRI is being replaced and the new machine will be operational in the coming weeks. Normal operating times are 7:30 to 18:00 Monday through Friday. St. Paul's Hospital MRI operates from 7:30 to 24:00 Monday through Friday and 8:00 to 16:00 on weekends. On call services are available after hours.

In Prairie North Health Region, a mobile MRI unit is being operated in conjunction with the Alberta Health Services Board, which visits the Lloydminster Hospital one in every five weeks for four tenhour days. A fifth ten-hour day has been added in recent months to accommodate additional patients. This service cares for both Alberta and Saskatchewan residents in the area.

Ms. Junor asked the Government the following Question No. 980, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: What are the vacancies for all technicians in each health region in the province?

The ministry does not collect this information.

Ms. Junor asked the Government the following Question No. 983, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: (1) How many children with respiratory issues were referred out of province in 2011? (2) 2010? (3) 2009? (4) 2008? (5) 2007?

Answer:

The ministry does not collect this information, more specifically:

- Respiratory issues do not specifically require prior approval to receive treatment out of province, and therefore referrals are not required or tracked;
- Reports provided on out-of-province hospital services are not broken down by age; and
- Diagnostic information that could capture respiratory issues would be very broad and inconsistently reported across other jurisdictions.

Ms. Junor asked the Government the following Question No. 984, which was answered by the Hon. Ms. Draude:

To the Minister of Social Services: (1) Is there a smoke-free policy for the Saskatoon Housing Authority? (2) If so, what is it?

Answer:

- (1) Yes.
- (2) The policy prohibits smoking in lounges, hallways, lobbies and other common areas in multi-unit buildings.

Ms. Junor asked the Government the following Question No. 985, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: Does the Saskatchewan formulary include nicotine replacement therapy? Answer:

The Saskatchewan Formulary does not list nicotine replacement therapy.

Ms. Junor asked the Government the following Question No. 986, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: (1) What is the wait list for spirometries in Regina? (2) Saskatoon? Answer:

The Saskatoon and Regina Qu'Appelle Health Regions do not track the number of patients waiting for spirometry tests.

Ms. Junor asked the Government the following Question No. 987, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many general pediatricians are there in Saskatoon? Answer:

There were 24 registered* general pediatricians in Saskatoon as of December 2010.

*Registered physicians are all physicians on the Medical Care Insurance Physician Registry except for those we know are retired, educational locums, residents and interns.

Ms. Junor asked the Government the following Question No. 988, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: How many specialized pediatricians are there in Saskatoon? Answer:

There were 27 registered* specialized pediatricians in Saskatoon as of December 2010. This is in addition to the 24 general pediatricians in Saskatoon.

*Registered physicians are all physicians on the Medical Care Insurance Physician Registry except for those we know are retired, educational locums, residents and interns.

Ms. Junor asked the Government the following Question No. 989, which was answered by the Government:

To the Government: (1) Does the Ministry of Health or the Ministry of Environment do tier 1 soil testing for radon gas? (2) If so, how does it do the testing?

Answer:

- (1) No.
- (2) N/A

Ms. Junor asked the Government the following Question No. 990, which was answered by the Government:

To the Government: (1) How many social assistance recipients have used up their 12 chiropractic visits in 2011? (2) 2010?

Answer:

- (1) For the period April 1, 2010, to March 31, 2011, 836 Supplementary Health clients had received 12 paid-for chiropractic care visits.
- (2) For the period April 1, 2010, to December 31, 2010, 512 Supplementary Health clients had received 12 paid-for chiropractic care visits.

Ms. Junor asked the Government the following Question No. 991, which was answered by the Government:

To the Government: How many social services recipients receive paid-for chiropractic care? Answer:

This question is not answerable as asked, given the lack of timeframe.

Ms. Junor asked the Government the following Question No. 992, which was answered by the Hon. Mr. McMorris:

To the Minister of Health: (1) How much money has the Saskatchewan Association of Health Organizations spent on leaflets, posters, letters, flyers and other workplace advertising about contract negotiations with the Health Sciences Association of Saskatchewan in 2009/10? (2) 2010/11?

Answer:

The Saskatchewan Association of Health Organizations does not differentiate between public and workplace advertizing. See the answer to Written Question No. 898.

Ms. Chartier asked the Government the following Question No. 993, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: Where is the Status of Women office now found in the budget?

Answer:

Included in Ministry of Social Services – Central Management and Services.

Ms. Chartier asked the Government the following Question No. 994, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: Why is the Status of Women office no longer appearing as a line item?

Answer:

The Status of Women is now considered a component of policy and planning within Ministry of Social Services – Central Management and Services.

Ms. Chartier asked the Government the following Question No. 995, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: What is the total budget estimate for the Status of Women office for 2011/12?

Answer:

\$435,000 plus an adjustment for any salary increases.

Ms. Chartier asked the Government the following Question No. 996, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: What was the total budget estimate for the Status of Women office for 2010/11?

Answer:

\$435,000.

Ms. Chartier asked the Government the following Question No. 997, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: What is the forecast for the Status of Women office for the 2010/11 year?

Answer:

\$429,000.

Ms. Chartier asked the Government the following Question No. 998, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: Has the mandate of the Status of Women office changed?

Answer:

No.

Ms. Chartier asked the Government the following Question No. 999, which was answered by the Hon. Ms. Draude:

To the Minister Responsible for the Status of Women: How many staff people are employed with the Status of Women office?

Answer:

Three.

Ms. Chartier asked the Government the following Question No. 1000, which was answered by the Hon. Mr. Hutchinson:

To the Minister of Tourism, Parks, Culture and Sport: Prior to the heritage property de-designation in April 2010, was the renovation work with the KIP funding at St. Peter's College in Muenster approved by the Minister of Tourism, Parks, Culture and Sport?

Answer:

The renovation work had been discussed by the ministry's heritage officials but no consent had been given.

Ms. Chartier asked the Government the following Question No. 1001, which was answered by the Hon. Mr. Hutchinson:

To the Minister of Tourism, Parks, Culture and Sport: (1) From whom did the request for the heritage de-designation of St. Peter's College come? (2) What was the rationale?

Answer:

- (1) The request to de-designate came from the registered property owner, the Order of St. Benedict.
- (2) The rationale of the property owner was that extensive physical upgrades were essential to accommodate modern technology and provide full wheelchair accessibility in order for the college to continue providing modern, high quality educational programming.

Ms. Chartier asked the Government the following Question No. 1002, which was answered by the Hon. Mr. Hutchinson:

To the Minister of Tourism, Parks, Culture and Sport: When the request for the de-designation came in from St. Peter's College, what were the recommendations from the ministry regarding the dedesignation of St. Peter's as a provincial heritage property?

Answer:

When the request came, the ministry recommended de-designation.

Ms. Chartier asked the Government the following Question No. 1003, which was answered by the Hon. Mr. Hutchinson:

To the Minister of Tourism, Parks, Culture and Sport: (1) Did the minister do any public consultation before choosing to de-designate St. Peter's College? (2) If not, why not?

Answer:

- (1) No public consultation was undertaken.
- (2) Where the minister has given consent to an owner's request for revocation of a provincial heritage property designation, there is no requirement under s.54 of *The Heritage Property Act* to consult with any party.
