- (1) The Efficiency Secretariat was established by merging resources from the former P3 Secretariat at Government Services with the Performance Management Branch within the Ministry of Finance. No new resources were provided for the Secretariat. The two branch budgets were combined to provide annual fiscal year funding of \$1,054,000 [\$650,000 from the P3 Secretariat and \$404,000 from the Performance Management Branch] and 8 FTEs.
- (2) For the period of October 1, 2009 to March 31, 2010, the estimated expense for the Secretariat is approximately \$527K.

- 1. A contract with Trafick Interactive Media Solutions for \$11,812 to desktop 23 ministry plans that were released with the 2010/11 budget. The contract ran from February to March 2010. Savings were estimated at approximately \$23,000.
- 2. A five week contract for \$9,000 with Kaizen Institute Lean Advisors to:
 - Undertake an assessment of whether and in what ways Lean could successfully be applied to assist with an efficiency assessment of Saskatchewan provincial court operations; and,
 - Provide recommendations as to how to proceed with a formal Lean project.

The following table shows GFSF balances and transfers between the GFSF and the General Revenue Fund from the GFSF's establishment to the 2010/a11 First Quarter forecast.
