Mr. Forbes asked the government the following Question No. 122, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #3 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "The Workers Compensation Board examine all rate groups with a view to determining groups in as fairly and balanced a way as possible. The impacts of any changes be analyzed actuarially and a sensitivity analysis of any changes provided"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Implemented. The WCB believes that this recommendation, in effect, endorses the process it uses now. WCB policies govern assigning or changing classifications, and employer appeals. During each year, the board examines the classification of several industries. An overall sensitivity analysis is carried out every five years.

Mr. Forbes asked the government the following Question No. 123, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #4 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "The Government of Saskatchewan, working with WCB and all public sector employers, take steps to ensure that it is a model employer and an example to the private sector with respect to safe work places and working towards the elimination of claims and injuries"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

- (1) Partially implemented. A variety of activities are underway to improve safety in the public sector.

Mr. Forbes asked the government the following Question No. 124, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #5 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "In those instances where an industry has a safety association, those safety associations have the primary responsibility to develop and deliver safety and prevention programming to support employers in creating a safe and injury free workplace"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Implemented. The WCB believes that this recommendation, in effect, endorses the process it uses now. WCB policies govern safety associations. The WorkSafe strategic partnership coordinates the activities of the WCB, the Ministry of Labour Relations and Workplace Safety, and safety associations in developing and delivering prevention programs.
- (2) None.

Mr. Forbes asked the government the following Question No. 125, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #6 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "In cases where an industry has no safety associations, WCB actively pursue the formation of safety associations. Where no such associations are formed, WCB be responsible to ensure that employers have access to safety and prevention programming with the costs of these WCB activities borne by those participating rate groups"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Implemented. The WCB believes that this recommendation, in effect, endorses the process it uses now. WCB policies do not specify that WCB can or should unilaterally solicit new safety associations. Nevertheless, this is done through the WorkSafe strategic partnership.
- (2) None.

Mr. Forbes asked the government the following Question No. 126, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #7 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "WCB continue to fully share information with OHS on claims histories and injury data by employer, so that OHS can apply its efforts in ways that lead to the greatest injury reduction and largest improvements in safety. WCB report to stakeholders and OHS on the effectiveness of OHS' activities"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Implemented. The WCB believes this is an endorsement of what the WCB is already doing to share information with the Ministry of Labour Relations and Workplace Safety.
- (2) None.

Mr. Forbes asked the government the following Question No. 127, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #8 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "The maximum benefit level which is currently set at \$55,000 be raised immediately to \$59,000. Over the next 4 years, it be increased annually by a percentage of the annual average wage in Saskatchewan until it reaches 165% of that average annual wage. Henceforth, the maximum be adjusted yearly to remain at 165% of the annual average wage in the province"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

- (1) Implemented.
- (2) Section 37.

Mr. Forbes asked the government the following Question No. 128, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #9 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "WCB develop processes to minimize moral hazard"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

(1) Implemented. The WCB is aware of this issue. The policies and the resources of the WCB aim for appropriate claim decisions and disability management. Senior WCB managers spend considerable time reviewing policies and trends in claim results. In the few cases where actual

fraud occurs, the WCB seeks prosecution through the justice system. A tips line is available for the public to report any instances of suspected fraud. It is an ongoing commitment for the WCB to improve its effectiveness and adopt best practices in claim processes.

Mr. Forbes asked the government the following Question No. 129, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #10 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "Amend subsection 74(3) to allow the worker to choose to either purchase an annuity or receive a lump sum payment when the accumulated capital and interest is \$25,000 or less in 2012 and to adjust the \$25,000 in increments of \$1,000 annually in subsequent years to reflect the average percentage change in the Consumer Price Index"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

(1) Implemented.

(2) Section 73.

Mr. Forbes asked the government the following Question No. 130, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #11 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "WCB inform claimants taking out annuities about the options and consequences of choosing an inflation protected annuity versus a flat rate option"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Disagree with recommendation. The WCB has always declined to advise workers about the type of retirement income investment they should make. The WCB does not have the expertise or the authority to do this. The legislation and WCB policies only address payment for life and guarantee of capital. The WCB encourages workers to seek expert financial advice from financial advisers.
- (2) None.

Mr. Forbes asked the government the following Question No. 131, which was answered by the Hon. Mr. Morgan:

To the Minister of Labour Relations and Workplace Safety: (1) What is the status of implementing recommendation #12 (Workers' Compensation Act, Committee of Review, Final Report, 2011) that states: "WCB actively pursue enhancement of effective strategies for education and follow up with physicians and other healthcare providers with respect to return to work"? (2) What specific sections of Bill 58, *The Workers' Compensation Act, 2012* apply to this recommendation?

Answer:

- (1) Implemented. The WCB believes that this recommendation, in effect, endorses the process it uses now. The WCB continues to pursue negotiations and written agreements with healthcare professional associations, including the Saskatchewan Medical Association. A continuum of care advisory committee made up of worker, employer and healthcare stakeholders also advises the WCB on this subject.
- (2) None.
