QUESTIONS AND ANSWERS

Ms. Chartier asked the government the following Question No. 315, which was answered by the Hon. Mr. Marchuk:

To the Minister of Education: (1) How much does it cost to create a single child care space? (2) What is the budgeted capital allotment to create a child care space?

Answer:

- (1) Government funding to create a single child care centre space (non school-based) is \$4,221 which includes:
 - Space development capital grant \$3,360
 - Start-up grant \$615
 - Enriched learning environment grant \$246

Government funding to create a single child care centre space (school-based) is \$846 which includes:

- Start-up grant \$615; and
- Enriched learning environment grant \$246.
- (2) Non school-based child care centres may be eligible for the space development capital grant of \$3,360/child care space. School-based child care facilities are typically eligible for capital funding up to a maximum of \$500,000/facility.

Ms. Chartier asked the government the following Question No. 317, which was answered by the Hon. Mr. Marchuk:

To the Minister of Education: Why in 2012/2013 were there \$4 million in capital transfers for childcare and only \$1.7 million in 2013/2014 when the same number of spaces (500) were/will be created?

Answer:

Child care capital needs vary from year to year depending on the type and scope projects being developed. School-based child care centre space development is supported through child care capital and major capital funding. A number of school-based sites that will be operational in 2013/14 will be supported through major capital funding instead of through child care capital funding.

To the Minister of Parks, Culture and Sport: Of the \$6.5 million allotted to *Creative Saskatchewan*, what does this include and the respective amount for each item, program etc.?

Answer:

The ministry is currently consulting on the design of *Creative Saskatchewan* with a working group of creative industry representatives. As consultations continue, focus will be paid to the amount of funding allocated specifically for programming initiatives.
