### **QUESTIONS AND ANSWERS**

# Mr. Belanger asked the government the following Question No. 585, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: Why was the location of the no. 1 bypass at Tower road the best location to serve the community for 50 years as stated by the ministry of Highways?

#### Answer:

This location was deemed to be the best option as it took into consideration several criteria:

- Generally accepted engineering principals and the Transportation Association of Canada Standards were used in multiple studies and functional design reports.
- Traffic safety.
- Project cost.
- Proximity to other planned interchanges.
- Planning for future northeast connector.
- Environmental criteria.

As well, significant municipal involvement and public engagement took place during the selection process.

# Mr. Belanger asked the government the following Question No. 587, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: Is the complete Regina Highway 1 bypass functional study available to the public?

#### Answer:

Numerous studies for the Regina Highway 1 bypass have been completed. Results of the studies outlined in Written Question No. 586 have been shared with the public through open houses.

# Mr. Belanger asked the government the following Question No. 588, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: (1) Did the study for the bypass in 2012/13 look at all options for the no. 1 bypass including Pilot Butte road, Gravel Pit road, and Tower road? (2) Are these studies publicly available?

#### Answer:

- (1) Yes.
- (2) Yes.

# Mr. Belanger asked the government the following Question No. 589, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: (1) Considering the bypass is intended to best serve the community for 50 years, did the study look at routes from Balgonie going south and/or Highway 46? (2) What would be the functionality, long-term benefits, and cost differences of these choices compared to the route announced?

#### Answer:

- (1) Yes.
- (2) An engineering performance evaluation takes a number of factors into consideration and assigns a 'weight' to each. The outcomes of the 2012 performance evaluation place the selected route ahead of other potential routes.

# Mr. Belanger asked the government the following Question No. 591, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: (1) What per cent of the vehicle traffic coming into Regina does the ministry anticipate will use the bypass? (2) What per cent of the truck traffic coming into Regina does the ministry anticipate will use the bypass?

#### Answer:

- (1) The per cent of all vehicles on Highway 1 East, Highway 1 West, and Highway 6 South that are anticipated to use the bypass is approximately 40 per cent. For Highway 33 and Highway 11, this percentage is approximately 30 per cent.
- (2) The per cent of trucks on Highway 1 East that are anticipated to use the bypass is approximately 70 per cent.

# Mr. Belanger asked the government the following Question No. 592, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: (1) How many people are losing their homes and businesses to the Regina Highway 1 bypass at Tower road? (2) How many people would lose their homes and businesses if the bypass was at Gravel Pit road?

#### Answer

- (1) Two homes, two businesses, and one ball field facility.
- (2) Two to three homes, three to four businesses. Additionally, Pilot Butte and area (including Ochapowace) would lose direct access to Highway 1.

# Mr. Belanger asked the government the following Question No. 593, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: Why was the proposed location of Highway 1 bypass moved from Tower road to 400 meters east of Tower road?

#### Answer:

- Allows a broader turn radius to maintain 110 km/hour, free-flow operation for traffic on Highway
- Provides a high level of service for traffic destined to Victoria Avenue.
- Provides a buffer between the Southeast Regina bypass and existing urban development.
- Can provide a connection to the future Northeast Regina bypass if required.
- Moves Highway 33 interchange away from Chuka Creek and meets long term traffic volumes.
- Provides flexibility for future infrastructure at the Tower road and Victoria Avenue intersection, should it be required.
- Ability to keep all lanes on existing Highway 1 open during construction.

# Mr. Belanger asked the government the following Question No. 594, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: Why is the diverging diamond interchange proposed the best interchange to build at Pilot Butte road?

#### Answer:

The diverging diamond interchange (DDI) has several advantages including:

- Fewer conflict points.
- Better sight distance at turns.
- Ease of left and right turn movements.
- Increased capacity.
- Shorter traffic signal times required.
- Can synchronize traffic signals at ramp terminals to minimize delays.
- U-turns can be easily accommodated.

- Typically requires less right-of-way.
- Construction time reduced.
- The vast majority of open house attendees preferred the DDI.

# Mr. Belanger asked the government the following Question No. 595, which was answered by the Hon. Ms. Heppner:

To the Minister of Highways and Infrastructure: (1) Has the diverging diamond interchange ever been built in Canada? (2) What studies were completed? (3) What was the rationale to support the diverging diamond interchange at Pilot Butte?

#### Answer:

- (1) No. However, there are a growing number of diverging diamond interchanges in operation in the United States (US) and Europe.
- (2) Following the implementation of diverging diamond interchanges in the US, surveys have been conducted by transportation officials seeking feedback as to the ease of travel, perceived operations and safety benefits, as well as general comments. Some of the subjective feedback noted through the course of this survey follows:
  - Cost savings may be in the range of 50 to 75 per cent compared to other designs when retrofitting an existing interchange site.
  - Construction time is typically reduced.
  - 97 per cent of drivers felt safer compared to the previous diamond interchange (Missouri DOT survey).
  - Crash data showed a 60 per cent reduction in collisions in a five-month comparison of the old interchange configuration (Missouri DOT).
  - Only 11 reported minor crashes were reported within a five-year time span of implementation (Versailles, France).
  - 95 per cent of drivers felt that there was less congestion compared to the previous diamond interchange (Missouri DOT survey).
  - Mile long queues were eliminated.
- (3) Advantages of the diverging diamond interchange (DDI)
  - Fewer conflict points.
  - Better sight distance at turns.
  - Wrong way entry to ramps difficult.
  - Ease of left and right turn movements.
  - Increased capacity.
  - Better vehicle storage between ramp and terminals.
  - Shorter signal times required.
  - Can synchronize signals at ramp terminals to minimize delays.
  - U-turns can be easily accommodated.
  - Typically requires less right-of-way.
  - Construction time reduced.
  - DDI design is cost effective and performs at an acceptable level of service.

#### Answer:

- (1) None of the \$4 million has been spent since it was received.

#### Answer:

The payment was meant to share past and future costs of preventing outflow of saline water from Houghton Lake to Lenore Lake. Water Security Agency continues to prevent overflow of saline water from Houghton Lake to Lenore Lake and has, since 2010, spent in excess of \$4 million on costs related to preventing overflow from Houghton Lake. Due to rising water levels Water Security Agency is currently negotiating with several landowners on additional compensation for flooded lands.
