#### STATEMENT BY THE SPEAKER

(Ruling on Bill No. 611 – Requirement for a Royal Recommendation)

Standing on the Order Paper for Second Reading under the name of the Member for Saskatoon Centre (Mr. Forbes) is Bill No. 611, *The Student Bill of Rights Act, 2015*. The bill was introduced on April 16, 2015.

It is the Speaker's duty to review all bills with respect to Rule 67 of the *Rules and Procedures of the Legislative Assembly of Saskatchewan*. The rule states, in part, that any bill which proposes to impose any new or additional charge upon the public revenue must be first recommended by the Lieutenant Governor before it is considered by the Assembly. The practice in this Assembly is for bills to be introduced and read the first time with further progress being contingent upon the Speaker affirming that they are in order under Rule 67. In Saskatchewan practice, consideration is taken to mean the first opportunity for debate. Pursuant to Rule 24(3), this bill could be designated for priority consideration today and taken up for Second Reading on Thursday. For this reason it is necessary for me to rule today on the admissibility of this bill.

When a private Member proposes a public bill to the Assembly, the test is to determine if it imposes a new responsibility, task or commitment on the government that requires expenditure from the public treasury. Bill No. 611 proposes a Student Bill of Rights, which is set out in clause 3 and further defined by the interpretation clauses. Under *The Education Act*, 1995 the government is responsible for setting the operating grants for the provincial education system and in doing so is responsible for requiring compliance with any terms and conditions that may be imposed on a grant. In this regard, the Minister has discretion to approve or reject any term or condition on funding.

The bill limits that discretion, and in my view would impose a contingent liability on the government to meet the standards imposed by Bill No. 611, if it were to pass into law. It follows that it would be the duty of the government, through its responsibility to provide operating grants, to fund the costs connected with the imposition of the Student Bill of Rights.

Erskine May, 24<sup>th</sup> edition, p. 747, states that a Crown recommendation is required for "any proposal whereby the Crown would incur a liability or a contingent liability payable out of money voted by Parliament." May also states in the same section the following: "If there is any doubt on the matter and it appears that the new proposal may entail an extension of previously enacted purposes of expenditure or an increase in the expenditure *potentially* liable to be incurred in pursuit of such a purpose, a Money resolution will be required."

I have expressed my concern over the contingent liability that would result from the passage of Bill No. 611. For that reason, I must rule that Bill No. 611 requires a Crown recommendation and because the Member for Saskatoon Centre is not a member of the Executive Council, I must rule that the bill is out of order and direct that is removed from the Order Paper.

Thereupon, Bill No. 611 was withdrawn.

### **QUESTIONS AND ANSWERS**

To the Minister Responsible for the Saskatchewan Power Corporation: (1) How many of the removed smart meters had experienced a failure that was not overheating? (2) What was the nature of those other failures?

Answer:

(1) 271

(2) The nature of these failures was as follows: meter did not power up or display properly; failure to communicate with the network; physical damage to the meter during shipping or installation.

To the Minister Responsible for the Saskatchewan Power Corporation: How many of the removed smart meters had experienced an overheating failure?

Answer:

10

### Ms. Sproule asked the government the following Question No. 910, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: Specifically, how did technical issues combine to result in the failure and/or fires of smart meters removed by order of cabinet?

#### Answer:

Technical issues combined to cause electrical arcing inside the meter.

# Ms. Sproule asked the government the following Question No. 911, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: What were the technical issues that contributed to the failures and/or fires of the smart meters removed by order of cabinet?

Answer:

Moisture and dust contamination combined to cause electrical arcing inside the meter.

# Ms. Sproule asked the government the following Question No. 912, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: What was the nature of the failures that occurred in the meters that were installed to replace the smart meters?

#### Answer:

Meter did not power up or display properly; physical damage to the meter during shipping or installation/operation.

# Ms. Sproule asked the government the following Question No. 913, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: How many failures occurred in the meters that were installed to replace the smart meters?

Answer:

45 meters did not power up, display properly, or incurred shipping or physical damage.

## Ms. Sproule asked the government the following Question No. 914, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: On which date did the first failure in the meters used to replace smart meters occur?

Answer:

SaskPower's official record for a meter failure is the date it is retired in the corporate meter inventory system; in the case of this meter, that was December 10, 2014.

## Ms. Sproule asked the government the following Question No. 915, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: On which date did the most recent failure in the meters used to replace smart meters occur?

Answer:

SaskPower's official record for a meter failure is the date it is retired in the corporate meter inventory system; in the case of this meter, that was April 10, 2015.

## Ms. Sproule asked the government the following Question No. 916, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: Were there overheating failures and/or fires in any of the meters that were installed to replace smart meters?

Answer:

No.

## Ms. Sproule asked the government the following Question No. 917, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: In how many of the meters that were used to replace smart meters did overheating failures and/or fires occur?

Answer:

None.

### Ms. Sproule asked the government the following Question No. 918, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: What technical issues contributed to the failures of the meters that replaced the smart meters?

Answer:

Meter did not power up or display properly; physical damage to the meter during shipping or installation/operation.

# Ms. Sproule asked the government the following Question No. 919, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: How are the failures in the meters used to replace smart meters being addressed?

#### Answer:

Meters that did not power up, display properly, or incurred shipping damage are being sent back to the meter manufacturer for warranty replacement.

# Ms. Sproule asked the government the following Question No. 920, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: What have been the costs incurred to replace any failed meters used to replace smart meters?

Answer:

No monies have been spent, as meters that did not power up, display properly, or incurred shipping damage are being sent back to the meter manufacturer for warranty replacement.

# Ms. Sproule asked the government the following Question No. 921, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: Has SaskPower, to this point, advised the public of the failure of the meters used to replace the smart meters?

Answer:

No public advisory is required, as the nature of these failures did not impact the public.

# Ms. Sproule asked the government the following Question No. 922, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: On what date was the Minister Responsible for SaskPower advised of overheating failures and/or fires of the meters used to replace smart meters?

#### Answer:

There were no overheating failures and/or fires, so the minister responsible was not advised.

# Ms. Sproule asked the government the following Question No. 923, which was answered by the Hon. Mr. Boyd:

To the Minister Responsible for the Saskatchewan Power Corporation: On what date was the Minister Responsible for SaskPower advised of the overheating failures and/or fires of the meters used to replace smart meters?

#### Answer:

There were no overheating failures and/or fires, so the minister responsible was not advised.
