QUESTIONS AND ANSWERS

Ms. Chartier, asked the government the following question no. 188, which was answered by the Hon. Mr. Reiter:

To the Minister of Health: (1) How many community treatment orders (CTOs) have there been since *The Mental Health Services Act* changed on October 31, 2015 in the Saskatoon Health Region? (2) The Regina Qu'Appelle Health Region?

Answer:

- (1) Saskatoon Health Region reports that they have had 275 individuals under CTO from October 31, 2015 to November 1, 2016. This number includes individuals under CTO in portions of the fiscal years of 2015-16 and 2016-17.
- (2) Regina Qu'Appelle Health Region reports that they have had 68 individuals under CTO from October 31, 2015 to November 1, 2016. This number does not include CTOs that are put in place by fee-for-service psychiatrists where the CTOs do not include the requirement for regional health authority (RHA) mental health staff supports. There is no requirement for the fee-for-service psychiatrists to provide details to the health region and as such is not easily comparable to the Saskatoon number.

Ms. Chartier, asked the government the following question no. 189, which was answered by the Hon. Mr. Reiter:

Answer:

RHAs did not track the number of individuals under CTOs prior to 2013-14. The numbers are not a count of CTOs as they were often renewed every three months and then for periods up to six months with the amendment of the legislation.

^{*}Regina Qu'Appelle Health Region no longer tracks CTOs completed by fee-for-service psychiatrists unless the RHA mental health staff are also involved in the services for the client. The number of CTOs appears larger in this time period as it was prior to a number of psychiatrists moving from the RHA's mental health clinic to becoming a fee-for-service psychiatrist in their own clinic. Numerous clients under CTO but not requiring RHA mental health staff involvement followed their psychiatrists to these independent practices.

Answer:

No additional funding was provided to the RHAs connected to the amendments to *The Mental Health Services Act*. The amendments are expected to reduce some long stays and readmissions thus reducing pressures and associated costs for RHAs.

Community mental health nurses are not the only discipline that provides care to mental health patients. The difference between these two RHAs is the staffing model and not a measure of care provided.
