QUESTIONS AND ANSWERS

The following responses to written questions were tabled by the government:

Question no. 258 (Ms. Sarauer):

To the Minister of Justice, (a) how many cases have been resolved through the Government of Saskatchewan's remand strategy program, (b) for each case resolved, what was the resolution, and (c) how many cases were resolved by the remand strategy program in each jurisdiction?

Answer:

- (a) There were a total of 811 cases reviewed on Sundays, of which 436 started the resolution process the next day. This does not include 14 weeks of data from Saskatoon and 4 weeks of data from Prince Albert, so total cases are expected to be higher.
- (b) The Ministry of Justice is collecting this data, but has not completed its analysis. It is understood that consent release, show cause hearing, or guilty pleas have occurred in most cases within one day.
- (c) There were 373 files in Saskatoon and 63 files in Prince Albert that started the resolution process the next day. This does not include 14 weeks of data from Saskatoon and 4 weeks of data from Prince Albert, so total cases are expected to be higher.

Question no. 259 (Ms. Sarauer):

To the Minister of Justice, how many Provincial Court trial dates have been cancelled in Weyburn since January 1, 2017?

Answer:

There have been no Provincial Court trial dates cancelled in Weyburn since January 1, 2017.

Question no. 260 (Ms. Sarauer):

To the Minister of Justice, (a) how much has been spent on renovations at the Estevan Queen's Bench court house since January 1, 2017, and (b) what is the budgeted cost of planned renovations at the Estevan Queen's Bench court house in 2018-19?

Answer:

- (a) \$104,500 has been spent on tenant improvements at the Estevan Queen's Bench court house since January 1, 2017.
- (b) The budgeted cost of planned renovations at the Estevan Queen's Bench court house in 2018-19 is \$0.

Question no. 261 (Ms. Sarauer):

To the Minister of Justice, (a) how much has been spent on travel and accommodations for staff, including judiciary, to Weyburn since January 1, 2017 for court matters, and (b) how much has it cost for travel and accommodations for staff, including judiciary, to Estevan since January 1, 2017 for court matters?

Answer:

- (a) There have been no travel costs for court matters to Weyburn since January 1, 2017. Weyburn Provincial Court is continuing to be used as a circuit point as it has been since 2009. The financial system that contains expenditure data is not configured to track travel to circuit points.
- (b) The financial system that contains expenditure data is not configured to track travel to a certain location. However, there have been no travel costs to the Judicial Centre of Estevan since January 1, 2017 outside the normal course of business as Estevan is a permanent judicial centre location.

Question no. 262 (Ms. Sarauer):

To the Minister of Justice, (a) how many additional full-time equivalents (FTEs) have been added to the Estevan Queen's Bench court house since January 1, 2017, (b) how many Queen's Bench trials have been held at the Days Inn in Estevan since January 1, 2017, (c) what is the current wait time for a Queen's Bench trial in Estevan, (d) what is the average length of the chambers list in Estevan Queen's Bench, by number of cases since January 1, 2017, and (e) what is the longest length of the chambers list in Estevan Queen's Bench, by number of cases since January 1, 2017?

Answer:

- (a) A permanent full-time position was transferred from Weyburn on January 1, 2017 and a .5 term employee was hired in March, 2017, for a total of 1.5 FTEs.
- (b) There have been no trials held at the Days Inn in Estevan since January 1, 2017.
- (c) The current wait time for a Queen's Bench trial in Estevan is approximately 5 months.
- (d) The average length of the chambers list in Estevan Queen's Bench since January 1, 2017 is 22.
- (e) The longest length of the chambers list in Estevan Queen's Bench since January 1, 2017 is 43.

Question no. 263 (Ms. Sarauer):

To the Minister of Justice, (a) what is the status of the occupational health and safety complaint regarding the reduction of deputy sheriffs in court houses, and (b) are deputy sheriffs or commissioners being used to transport inmates from court locations to jails?

Answer:

- (a) The ministry submitted its final report to occupational health and safety on December 15, 2017. Occupational health and safety informed the ministry that the notice of contravention was completed and closed as of that date.
- (b) Only deputy sheriffs are transporting prisoners from court locations to jails, not commissionaires.

Question no. 264 (Ms. Sarauer):

To the Minister of Justice, (a) in terms of Legal aid Saskatchewan, how many FTE positions are currently unfilled, and (b) what is the location of the unfilled positions?

Answer:

Legal Aid has two term lawyer positions (Prince Albert and Saskatoon Criminal) and two permanent support staff positions (Saskatoon Family, Saskatoon Rural) unfilled.

Question no. 266 (Ms. Sarauer):

To the Minister of Justice, for each additional training course/requirement for the members of the provincial response team, how many hours are required?

Answer:

Additional training course/requirement for conservation officers that become members of the provincial response team total 64 hours and is broken down as follows:

Domestic violence: 16 hours Mental health: 16 hours

Perimeter/Containment: 8 hours

Building clearing/Rapid deployment: 4 hours

Alcohol screening devices training—impaired driving: 12 hours

Diversity training: 8 hours

Additional training course/requirement for highway traffic officers that become members of the provincial response team is in development.

Question no. 268 (Ms. Sarauer):

To the Minister of Justice, (a) in terms of the Family Matters program, how many inquiries were made to Family Matters each year since 2016, (b) how many individuals received mediation each year since 2016, (c) how many individuals received legal advice each year since 2016, (d) what were

other possible outcomes of calls received, and (e) for each service offered, what is the average wait time for someone to access services through Family Matters each year since 2016?

Answer:

(a) Total inquiries:

November 2014–March 31, 2016—795 April 1, 2016–March 31, 2017—1,813 April 1, 2017–March 31, 2018—2,484

- (b) Mediation (problem solving sessions): Family Matters does not offer mediation. The program offers a free 3-hour problem solving session where parties are able to discuss their name issue(s)/concern(s) in the presence of a third-party. There were 97 sessions in 2016/17 and 93 session in 2017/18.
- (c) Referrals for legal advice: Family Matters does not provide legal advice. The program does provide legal information and legal resources for individuals who are looking for legal assistance. One of the main referrals that Family Matters makes for individuals to access legal information is to the Family Law Information Centre. This office is maintained by a lawyer with family law training. There were 664 people referred in 2016/17 and 856 people referred in 2017/18.
- (d) Possible Outcomes: The following is a list of the five (5) most common topics/resources that Family Matters provides information (following the Family Law Information Centre):

Self-Help kits (total sent as of March 31, 2018—349)

Property division workbook and resources (total sent as of March 31, 2018—262)

Parenting planning workbook and resources (total sent as of March 31, 2018—327)

Parenting After Separate and Divorce schedule (not separately tracked)

Mediation Resources (total sent as of March 31, 2018—231)

(e) Average wait time: If individuals want to attend a problem solving session, wait time is typically 3–4 weeks from intake to completion. If individuals on require information or resources, wait time is typically 24 hours or less.

Ouestion no. 269 (Ms. Sarauer):

To the Minister of Justice, what is the status of the fine option program redesign request for proposal? Answer:

The request for proposal (RFP) process for the fine option program redesign remains active. Submissions are being evaluated by a committee comprised of staff from the ministries of Justice, Corrections and Policing, and Central Services. It is anticipated that the RFP process will conclude May 31, 2018.

Question no. 270 (Ms. Sarauer):

To the Minister of Justice, (a) in terms of the Office of Residential Tenancies, how many files were opened in 2017-18, (b) how many FTEs were actively working at the end of the 2017-18 fiscal year, (c) how many FTEs were actively working at the end of the 2016-17 fiscal year, (d) how many FTEs are budgeted to be employed in 2018-19, (e) how many certificate applications have been made per s. 12.4 of *The Residential Tenancies Act*, 2006, as per the changes found in *The Victims of Interpersonal Violence Amendment Act*, and (f) how many certificate applications have been made per s. 12.4 of *The Residential Tenancies Act*, 2006, as per the changes found in *The Victims of Interpersonal Violence Amendment Act* have been approved?

Answer

- (a) The Office of Residential Tenancies opened 8,413 files in 2017-18.
- (b) At the end of the 2017-18 fiscal year, there were 16.1 FTEs.
- (c) At the end of 2016-17 fiscal year, there were 16.1 FTEs.
- (d) There are 16.1 FTEs budgeted for 2018-19.
- (e) 15 certificates applications were made.
- (f) 15 certificates were issued through Victim Services under *The Victims of Interpersonal Amendment Act*.

Question no. 272 (Ms. Sarauer):

To the Minister of Justice, (a) what is the current status of the Pelican Narrows court house construction, and (b) has the construction at the Pelican Narrows court house been deferred or will it take place in the 2018-19 fiscal year?

Answer:

- (a) A preliminary design has been completed. The ministry is pursuing federal funding assistance.
- (b) The construction of the Pelican Narrows court house has been deferred.

Question no. 277 (Ms. Sarauer):

To the Minister of Corrections and Policing, how many inmates have purchased the monthly call package as per the Synergy contract to provide telmate services to Saskatchewan correctional facilities?

Answer:

The number of call bundles purchased to date totals 5,344—inmates may have purchased more than one thus the response is centered around volume versus by individual.

Question no. 279 (Ms. Sarauer):

To the Minister of Corrections and Policing, (a) what is the percentage of inmates who have a diagnosed mental illness, and (b) of those inmates diagnosed with a mental illness, how many suffer from an addiction?

Answer:

Corrections does not have an electronic or automated tracking system that details the number of offenders who have both a mental illness and a substance abuse disorder. In 2015, Corrections undertook collecting a one-day static sample (a snapshot) of the mental health of the custody population. When completing the snapshot, collection did not include both mental illnesses and addictions—the snapshot was done in an attempt to keep the question straightforward and the answer as accurate as possible. Because of the lack of an automated system, information collection was done manually by nursing staff by reviewing paper files (which was a highly labour intensive and time consuming undertaking). This undertaking is not easily replicated. Given the mandate and first priority for nurses is to provide direct services to offenders the response to the written question is based on the 2015 mental health snapshot data.

Mental Health:

Based on the 2015 one-day snapshot of the mental health of the custody population:

- 17.6% of adults in custody had been diagnosed by a health professional with a mental illness or mental health problem; 5.7% of the custody population had a diagnosis of a severe mental illness (schizophrenia, bipolar disorder, or major depression).
- 18.8% of the diagnosed adults in custody had three or more diagnoses, not including any substance use disorder, indicating a high proportion of complex mental health problems.

Addictions-based Information:

Based on standardized risk assessments completed on offenders at the time of intake:

- 73% of sentenced male inmates reported frequent abuse of drugs or alcohol resulting in serious problems, and
- 89% of sentenced female inmates reported negative impact of substance abuse in two or more areas of their lives.

Question no. 280 (Ms. Sarauer):

To the Minister of Corrections and Policing, (a) in terms of the Battlefords community correctional centre, when is it scheduled to be closed, (b) where will the inmates be placed once it is closed, and (c) what are the primary residences of the current Battleford closed correctional facility inmates?

Answer:

In terms of the Battlefords community correctional centre:

- (a) it has a scheduled closure date set for September 1, 2018.
- (b) remaining inmates will be transferred to other reduced custody facilities by August 31, 2018.
- (c) 35% of the facility's population primary residency is from Battlefords with the remaining 65% located between North Battleford and Lloydminister/Onion Lake area.

Question no. 281 (Ms. Sarauer):

To the Minister of Corrections and Policing, (a) in terms of the North Battleford Youth Centre, when is it scheduled to be closed, (b) where will the inmates be placed once it is closed, and (c) what are the primary residences of the current Battleford closed correctional facility inmates?

Answer:

In terms of the North Battleford Youth Centre:

- (a) it has a scheduled closure date set for September 1, 2018.
- (b) remaining youth will be transferred to other young offender facilities by August 31, 2018—home location will guide placement.
- (c) the facility's population is showing primary residency in the following communities: Onion Lake, Montreal Lake, North Battleford, Prince Albert, Sandy Bay, Clearwater First Nation, Dillon, Denare Beach, La Ronge, Stanley Mission, Red Pheasant First Nation, Spiritwood, Mosquito First Nation, and Sputinow.

Question no. 282 (Ms. Chartier):

To the Minister of Health, how many qualified palliative care physician FTEs were working in 2013-14, 2014-15, 2015-16, 2016-17, and 2017-18?

Answer:

The ministry does not have information on the number of physicians with additional training in palliative care. Over the last five years, the number of physicians billing for this specific service is as follows:

2013-14: 104 physicians 2014-15: 113 physicians 2015-16: 142 physicians 2016-17: 153 physicians 2017-18: 219 physicians

Question no. 283 (Ms. Chartier):

To the Minister of Health, for each location that exists, how many acute palliative care beds were there in 2013-14, 2014-15, 2015-16, 2016-17, and 2017-18?

Answer:

Hospital palliative services can, and are, offered to patients as soon as a palliative diagnosis is indicated regardless of the "type of bed" the patient happens to be occupying at their time of need. Palliative care services are provided in designated palliative care beds, on inpatient units across the province, in designated hospices, and/or in many alternate level of care beds in health centers or integrated facilities which may not be hospitals. On a typical day, Saskatchewan hospitals cared for 171 palliative care patients.

Question no. 284 (Ms. Chartier):

To the Minister of Health, for each location that exists, how many hospice beds were there in 2013-14, 2014-15, 2015-16, 2016-17, and 2017-18?

Answer:

2013-14:10 beds (Grace Hospice at William Booth long-term care) 2014-15:10 beds (Grace Hospice at William Booth long-term care) 2015-16:12 beds (Grace Hospice at William Booth long-term care, Sanctum) 2016-17:12 beds (Grace Hospice at William Booth long-term care, Sanctum) 2017-18:12 beds (Grace Hospice at William Booth long-term care, Sanctum)

Question no. 285 (Ms. Chartier):

Answer:

The Ministry of Health provides global funding to the Saskatchewan Health Authority to provide all health services that includes palliative care.
