QUESTIONS AND ANSWERS

The following responses to written questions were tabled by the government:

Question no. 1 (Ms. Beck):

To the Minister of Education, for each of the joint-use P3 schools that had boot racks installed in common areas, (a) how much money was spent installing boot racks in common areas, (b) how many boot racks were installed, and (c) was the cost of installation paid for by JUMP (Joint Use Mutual Partnership), the school division, the provincial government, Johnson Controls, or any other entity?

Answer:

The provincial government provided \$6,030 to school divisions to cover the costs of installing nine boot racks in the common areas of the joint-use P3 schools.

Question no. 2 (Ms. Beck):

To the Minister of Agriculture, was the land parcel whose sale was authorized by order in council 509/2018 sold through an auction, a private sale, or some other method of sale?

Answer:

The land parcel sale was authorized by order in council 509/2018 in accordance with section 2-5 (2)(b) of *The Provincial Lands Act*, 2016.

Question no. 3 (Ms. Beck):

To the Minister of Central Services, what were the total costs associated for renovations of the lounge and cafeteria in the Legislative Building in 2016–17, 2017–18, and 2018–19?

Answer:

There were no renovations to the lounge and cafeteria in the Legislative Building in 2016–17 and 2017– 18. Any work that was completed was maintenance-related. The total costs associated with renovations of the lounge and cafeteria in the Legislative Building in 2018–19 were:

- Ceiling and wall painting \$4,995.00
- Mural located on the bulkhead in the serving line \$1,500.00
- 11 tables built specifically for the cafeteria \$1,500.00
- Flooring \$3,370.80 *This cost represents the purchase of vinyl flooring and the installation of carpet tile that was currently in inventory from other projects, deemed surplus.
- Five televisions \$1,950.00
