# **QUESTIONS AND ANSWERS**

#### The following responses to written questions were tabled by the government:

#### Question no. 25 (Ms. Wilson):

To the Minister of Justice and Attorney General, (a) will the government adopt the Peckford recommendation to refer all COVID-19 measures and workplace policies to the Court of Appeal by way of the refence procedure to determine if they are contrary to the law and, in particular, our Charter of Rights and Freedoms, and (b) what legal advice, if any, did the government seek prior to implementing the vaccine passport mandate and the mask mandate?

#### Answer:

(a) The government does not intend to direct a reference to the Saskatchewan Court of Appeal respecting our former COVID-19 public health measures. The government is confident that all former Saskatchewan public health measures were compliant with the Canadian Charter of Rights and Freedoms.

(b) The government sought legal advice from officials within the Ministry of Justice and Attorney General about the public health protections respecting proof of vaccination (or negative test) and masking prior to implementation. The precise nature of this legal advice is confidential.

#### Question no. 26 (Ms. Wilson):

To the Minister of SaskBuilds and Procurement, (a) when did Saskatchewan become a member of the Digital Identification and Authentication Council of Canada (DIACC), (b) who made the decision to join DIACC, (c) what consultation processes were used to obtain public input and opinion, and (d) what obligations does the province of Saskatchewan have to DIACC by being a member?

#### Answer:

(a) Saskatchewan joined DIACC in June 2019 and was a member until June 2021. No decision has been made regarding renewal.

(b) The former Ministry of Central Services (now the Ministry of SaskBuilds and Procurement) made the decision to join DIACC in order to help shape a Pan-Canadian Trust Framework. DIACC's principles emphasize topics like privacy, security, and providing Canadians choice and convenience.

(c) No formal consultation occurred.

(d) Membership in DIACC is non-binding and places no obligations on participating jurisdictions.

#### Question no. 27 (Ms. Wilson):

To the Minister of Health, (a) is it permitted for the COVID-19 vaccines to be administered to the public if the government lifts the current provincial state of emergency, (b) if yes, under what authority, and (c) if no, what date will it become permissible to administer the COVID-19 vaccines without a provincial state of emergency?

#### Answer:

(a) Ensuring access to immunization is a routine function of public health. Vaccines will continue to be available despite the provincial state of emergency being lifted.

(b) Authority to provide vaccines to the public exists through *The Health Administration Act* (unless superseded by another Act). To provide additional clarity regarding the delivery and administration of COVID-19 vaccines, amendments were made to *The Disease Control Regulations* (February 24, 2021 to March 31, 2021).

As of November 2021, vaccination programming (including COVID-19 vaccination) was moved into *The Public Health Act, 1994* to strengthen provisions set in *The Disease Control Regulations*. The regulation sunsets on March 31, 2022. The authority within *The Health Administration Act* remains.
