INTRODUCTION OF BILLS

The minister, having acquainted the Assembly that His Honour the Lieutenant Governor, having been informed of the subject matter of the bill, recommends it to the consideration of the Assembly, the following bill was introduced, read the first time, and ordered to be read a second time at the next sitting:

The following bill was reported without amendment and consideration in Committee of the Whole on Bills having been waived, by leave of the Assembly, it was read the third time and passed:

REPORT OF THE STANDING COMMITTEE ON PRIVATE BILLS

Mr. Steele, Chair of the Standing Committee on Private Bills, presented the fourth report of the said committee, which is as follows:

Your committee has considered the following bills and has agreed to report the same without amendment:

Bill No. 903 — The Collège Mathieu Act

Bill No. 904 — The United Church of Canada Amendment Act, 2021

And further, that the fees respecting Bills No. 903 and 904 be waived.

Your committee has considered the following bill and recommends the same be not further proceeded with:

Bill No. 902 — The Mennonite Union Waisenamt Amendment Act, 2021

Your committee recommends that the above bill not proceed based on the following:

The petitioners require further amendments to the legislation that were not included in the bill as printed.

The required amendments are beyond the scope of the bill as printed and therefore a new bill must be presented.

The events that gave rise to the amendments that are now required were beyond the control of the private entity.

Pursuant to rule 109, your committee recommends suspending the rules respecting this private bill and that a new bill be introduced in the Assembly by April 13, 2022, and that when the bill is read a second time, it is committed to the Standing Committee on Private Bills.

And further, once the committee reports on the bill to the Assembly, the rules for private bills shall apply.

On motion of Mr. Steele:

Ordered, That the fourth report of the Standing Committee on Private Bills be now concurred in.

Accordingly, the bill was removed from the Order Paper.
