STATEMENT BY THE SPEAKER Ruling on a Point of Order (Impugning Character of a Member)

Yesterday, May 11, 2022, the Government House Leader (Hon. Mr. Harrison (Meadow Lake)) rose on a point of order. He stated that during question period, the member from Regina Douglas Park (Ms. Sarauer) made an unfounded personal attack on the Minister of Corrections, Policing and Public Safety (Hon. Ms. Tell). I have reviewed *Hansard* and am now prepared to make my ruling.

The member from Regina Douglas Park's statement can be found on page 2438 of *Hansard*. In responding to an answer by the Minister of Corrections, Policing and Public Safety, the member stated:

"... a minister who has faced disciplinary measures in her previous career for the misuse of sensitive data."

Members should know by now, given numerous rulings from the Chair during this session, that remarks which impugn a member's integrity, honesty, or character are out of order. *The House of Commons Procedure and Practice*, 3rd edition 2017, p. 624, states that the Speaker takes into consideration the intention of the member speaking and the person to whom the words at issue were directed. I think the answer to that question is sufficiently clear. In her comment, the member attempts to call into question the character of the minister.

I find the point of order well taken and ask the member for Regina Douglas Park to withdraw and apologize.

Thereupon, the Member from Regina Douglas Park withdrew her comment and apologized.

The following questions were given notice on day no. 58 and are to be answered by day no. 63:

Question no. 34 (Ms. Ritchie):

To the Minister of Health, (a) in Saskatoon, how many hospital beds are dedicated to neurology-, stroke-, and/or seizure-related care, (b) in Saskatoon, how many patients have received in-hospital neurology-, stroke-, and/or seizure-related care since January 1, 2022, and (c) in Saskatoon, have neurology-, stroke-, and/or seizure-related hospital beds or resources been utilized for COVID surge capacity, and if so, when and to what degree?

Question no. 35 (Ms. Young (Regina University)):

To the Minister of Trade and Export Development, for each of the minister's international trips, from January 1, 2022 to present, (a) what was the total cost, (b) what was the minister's itinerary, (c) what were the anticipated outcomes, and (d) were any anticipated and/or realized agreements reached abroad and if so, please provide details?

To the Minister of Health, regarding mental health/detox facilities, (a) what policies/work standards/ procedures are in place to ensure that a person is psychologically stable, cognitively mature and free from any form of duress so as to ensure they can adequately provide informed consent, (b) how many vaccinations were administered in adult and youth acute mental health facilities and detox centres in Saskatchewan, (c) what was the legal status of those patients at the time — voluntary or involuntary — under the Saskatchewan mental health Act at the time of vaccination, and (d) what are the work standards/policies/procedures for vaccine administration on voluntary patients on a mental health inpatient unit for adults and youth?
