#### PRESENTING PETITIONS

Petitions of citizens of the province of Saskatchewan were presented and laid upon the Table by the following members: Harrison (Cannington), Love, Burki, and Sarauer.

#### READING AND RECEIVING PETITIONS

According to order and pursuant to rule 16(7), petitions from residents of the province of Saskatchewan, requesting the following action, were read and received:

To introduce and pass paid sick leave legislation.

To provide adequate, sustainable, and predictable operating funds for Saskatchewan's 27 public and separate school divisions.

To pass legislation to improve conditions for Saskatchewan workers.
