To provide adequate, sustainable, and predictable operating funds for Saskatchewan's 27 public and separate school divisions.

#### **MOTIONS FOR RETURNS**

Regarding *The Environmental Management and Protection Act, 2010, The Agricultural Packaging Product Waste Stewardship Regulations*, and the Saskatchewan Grain Bag Recycling Program, the criteria for the appointment of Cleanfarms as the program administrator, including all reporting and renewal processes for the Saskatchewan Grain Bag Recycling Program, for the years 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, and 2024.

## **QUESTIONS ORDERED FOR RETURN**

## The following written questions were converted and orders for return were issued:

## Return no. 4 (Ms. Sarauer):

To the Minister of Corrections, Policing and Public Safety, whether the ministry can answer the following questions about the placement of inmates at Saskatchewan Hospital North Battleford who should be housed at Pine Grove Correctional Centre: (a) the date the ministry began transferring inmates to Saskatchewan Hospital North Battleford who were supposed to be housed at Pine Grove Correctional Centre; (b) from the date that this started until present, the number of inmates that have been transferred to Saskatchewan Hospital North Battleford who are supposed to be housed at Pine Grove Correctional Centre; (c) the number of inmates from Pine Grove Correctional Centre at present and the point-in-time numbers for each month going back eight months; (d) whether the minister can explain why inmates are being sent to Saskatchewan Hospital North Battleford instead of Pine Grove Correctional, where they should be; (e) whether inmates that have been transferred to Saskatchewan Hospital North Battleford instead of Pine Grove Correctional, where they should be; (e) whether inmates that have been transferred to Saskatchewan Hospital North Battleford instead of Pine Grove Correctional, where they should be; (e) whether inmates that have been transferred to Saskatchewan Hospital North Battleford from Pine Grove Correctional Centre are able to access support and programming; (f) the type of programming and support they can access; and (g) whether inmates are being transferred from any other facilities to Saskatchewan Hospital North Battleford and, if so, from which facilities, and the number from each.
