STATEMENT BY THE SPEAKER Ruling on a Point of Order (Unparliamentary Language)

On Thursday, May 9, 2024, the Opposition House Leader (Ms. Sarauer) rose on a point of order alleging that, during the 75-minute debate, the Member from Moosomin (Mr. Bonk) referred to the Official Opposition as socialists. The Deputy Chair of Committees of the Whole Assembly (Mr. Fiaz) committed to reviewing the record.

The Deputy Chair of Committees and I discussed the matter, and I reviewed the *Hansard*. While the Member from Moosomin did refer to a socialist system on p. 5666, he did not reference opposition members in his statement. I therefore find the point of order not well taken.
