 - a) Removing the provincial sales tax from construction labour and restaurant meals,
 - b) Introducing a SaskFirst procurement model to ensure Saskatchewan workers are prioritized on public projects in Saskatchewan,
 - c) Introducing a \$15/hour minimum wage, phased in over the next four years, and
 - d) Prioritizing investments in renewable power to create good green jobs.

On the proposed **motion no. 2** moved by Ms. Ross (Prince Albert Northcote): That this Assembly calls on the federal government to immediately commit to long-term funding increases to the Canada Health Transfer, representing an increase from its current share of 22% to 35%, in order to keep pace with rising health care costs that are putting unsustainable financial pressure on provinces and territories.
