APPENDIX A

WRITTEN QUESTIONS

The following question was given notice on day no. 8 and is to be answered by day no. 13:

1. Question no. 43 (Ms. Wilson):

To the Minister of Health and the Minister of Mental Health and Addictions, Seniors and Rural and Remote Health, information obtained via a freedom of information request showed that the Ministry of Health reported there were 1,229 adverse reactions from December 30, 2020 to October 26, 2021, due to the experimental COVID-19 inoculations. During that time 1,649,640 injections had been given, therefore a reported reaction rate of .075 per cent or 7.5 for every 1,000 injections. On the Saskatchewan government website as of September 18, 2022, the total number of adverse reactions reported by the government was 1,320. That means only 91 more adverse effects were reported in the next 11 months during which an additional 920,000 injections were given. This is .0098 per cent reaction rate or 9.8 for every 10,000 injections. Statistically, that is a drastic change in ratio which raises the questions: (a) was the criteria for reporting adverse reactions changed after October 2021, and if so, how, why and by whom, (b) who or what government agency is responsible for monitoring adverse reactions, and what thresholds has the government set to determine whether the COVID-19 injection schedule(s) should be continued, halted, and/or modified, and (c) where can the public view this information?
