On the proposed **motion no. 3** moved by Mr. Bonk: That this Assembly supports the Government of Saskatchewan's policies that have resulted in the attraction of \$17.1 billion in capital investment to Saskatchewan in 2023, and are estimated to increase to \$19.6 billion in 2024, including the development of international trade offices; and further,

That this Assembly denounces the provincial NDP for their abysmal record of attracting capital investment to the province under their poor leadership, and for overseeing the decline of Saskatchewan's population. *Adjourned once*
