## STANDING COMMITTEE ON AGRICULTURE December 7, 1999

# MINUTE NO. 1 4:00 p.m. – Legislative Chamber

- 1. **PRESENT**: Mr. Lingenfelter in the Chair and Members Boyd, Bjornerud, Harpauer, Harper, Melenchuk, Serby, Wartman and Weekes
- 2. The Clerk to the Committee presided over the election of a Chair. Mr. Boyd nominated Mr. Lingenfelter for the position. There being no further nominations, it was moved by Mr. Wartman:

That nominations for the position of Chair close.

The question being put, the motion was agreed to. It was then moved by Mr. Boyd:

That Dwain Lingenfelter, Honourable Minister of Agriculture, be elected to preside as Chair of the Standing Committee on Agriculture.

The question being put, the motion was agreed to and Mr. Lingenfelter took the Chair.

3. The Chair of the Committee presided over the election of a Vice-Chair. Mr. Harper nominated Mr. Boyd for the position. There being no further nominations, it was moved by Mr. Wartman:
