**The Chair:** — I'll call this meeting to order, meeting 4/12 of the Board of Internal Economy. And present this morning, we have Mr. Morgan, Ms. Tell, Mr. Harrison, Mr. McCall, and Mr. Forbes. Somebody move that motion? Mr. Harrison. Secunder? Mr. Forbes. Any discussion?

It has been moved by Mr. Harrison, seconded by Mr. Forbes:

That the Board of Internal Economy recommend to the Assembly pursuant to 4(3) of *The Election Act, 1996* that Mr. Michael Boda be appointed the Chief Electoral Officer effective June 1, 2012.

All in favour? Carried.

**Hon.
