#### BOARD OF INTERNAL ECONOMY December 5, 2012

[The board met at 17:10.]

**The Chair:** — Okay, I'd like to call this meeting of the Board of Internal Economy to order. Before us we have the agenda for approval. If everyone's had a chance to have a look at it, could I have a motion please to adopt the agenda?

Hon. Mr. Morgan: — I so move.

**The Chair**: — Seconder?

Mr. Harrison: — I'll second that.

**The Chair:** — Mr. Harrison. All in favour of the agenda?

Some Hon. Members: — Agreed.

**The Chair:** — Carried. Okay. We have minutes of the meeting of 6/12. If people have taken, had the opportunity to have a look at it, are there any questions? If not, could somebody move that we adopt the minutes #6/12?

Mr. Harrison: — So moved.

**The Chair:** — Mr. Harrison. Seconder, Mr. Forbes. It has been moved by Mr. Harrison, seconded by Mr. Forbes that the proposed minutes #6/12 be adopted. Is it the pleasure of the committee to adopt the motion?

Some Hon. Members: — Agreed.

**The Chair:** — Carried. Okay, item no. 1 is a decision item, the request for a funding commitment for the Advocate for Children and Youth and the Ombudsman. Is there any discussion? I do have a recommended motion here. The recommended motion is:

That the Board of Internal Economy supports the Advocate for Children and Youth and the Ombudsman entering into a rental agreement for lease accommodation in Saskatoon.

Would somebody move that? Ms. Eagles. Seconder? Mr. McCall. It has been moved by Ms. Eagles, seconded by Mr. McCall:

Some Hon. Members: — Agreed.

**The Chair:** — Carried. Okay, that's item no. 1. Item no. 2 is a discussion item, review of the Board of Internal Economy directives. The only other item that I would like to mention for the committee is we do have a budget meeting coming up for review and consideration of the budgets of all the independent officers and the LAS [Legislative Assembly of Saskatchewan]. And we'd like to recommend that February 5th and 6th be the dates that you put on your calendar for this consideration. Is there any discussion on that?

**Ms. Eagles**: — That's February 5th and 6th. Would it be primarily the whole day, Dan?
