[The board met at 09:00.]

**The Chair:** — Good morning, everyone. I'd like to call the meeting to order. It is now 9 a.m. Attending this meeting is Ministers Harrison and Hindley, MLAs [Member of the Legislative Assembly] Terry Dennis, Alana Ross, Matt Love, and Nicole Sarauer.

Now I would like to have a mover and a seconder to approve the agenda. It states that the proposed agenda for the meeting 6/22 be approved as presented. Mover and seconder?

**Hon. Mr. J. Harrison:** — So moved.

**The Chair:** — Mr. Harrison, Ms. Sarauer. All in favour? Carried.

I need the approval of the minutes from the meeting 5/22. Could I have a mover and seconder. The mover is Sarauer, seconder Mr. Ross . . . Mr. . . . We'll get it. Mr. Dennis. All in favour of that garbled motion? You have to say yes, people. You're not listening.

**Some Hon. Members:** — Agreed.

**The Chair:** — Agreed. Carried.

So item no. 1 is a discussion and decision item, proposed changes to directives 3.1 and 4.1 and to the members' capital asset and disposal policy. The agenda item before the board consists of four motions, each making changes to directives. Could I have a mover and a seconder for the first one:

That directive #3.1 . . .

**Hon. Mr. J. Harrison:** — We haven't seen them yet.

**The Chair:** — You haven't seen any?

**An Hon. Member:** — Nothing.

**An Hon. Member:** — No.

**The Chair:** — It's based on what you guys agreed to.

**Hon. Mr. J. Harrison:** — I know what it can be based on, but we haven't seen it.

**The Chair:** — I'll read it.

**Hon. Mr. J. Harrison:** — Okay. Do we want to have a recess for a minute here and take a second to . . . Yeah.

**The Chair:** — Okay. Let's recess.

[The board recessed for a period of time.]

**The Chair:** — Okay, we'll reconvene. So we're going to deal with just one of the agenda items, and could I have a mover and a seconder for the motion:

That directive #3.1, clause 7 be amended by adding:

"Property management services which includes snow removal and property checks for insurance purposes." as new subclauses 7(a)(v) and 7(c)(vii).

**Hon. Mr. J. Harrison:** — Just half a second, Mr. Speaker.

**The Chair:** — Okay, could I have a . . . We're not going to do any business, so could I have someone move to adjourn?

**Hon. Mr. J. Harrison:** — So moved.

**The Chair:** — This meeting is adjourned at 9:10.
