BOARD OF INTERNAL ECONOMY December 2, 2014

[The board met at 08:31.]

The Chair: — I'd like to welcome everyone this morning here to the Board of Internal Economy meeting. With us this morning, we have the Government House Leader, Mr. Cheveldayoff; MLA [Member of the Legislative Assembly] Doreen Eagles; and the Hon. Nancy Heppner. For the opposition, we have the Opposition House Leader, Mr. Warren McCall; and MLA David Forbes.

You will have seen in your package information regarding Mr. Barclay. And he was, his five-year term is approaching its finality and we're seeking a recommendation from the board to reappoint him. I have a motion prepared. I'll read it out for you:

That the Board of Internal Economy recommends Hon. Ronald L. Barclay be reappointed as the Conflict of Interest Commissioner for one additional term of five years in accordance with section 18(4) of *The Members' Conflict of Interest Act*.

Would someone move that, please.

Mr. McCall: — So moved.

The Chair: — Mr. McCall. Seconder? Mr. Cheveldayoff. Any discussion? If not, all in favour?

Some Hon. Members: — Agreed.

The Chair: — Carried. I have a letter prepared here that I will send out to Mr. Barclay confirming his reappointment once this moves through the House.

So we will be asking Mr. McCall as the government lead to move this in the House today before orders of the day . . . [inaudible interjection] . . . Sorry, sorry. No. Mr. Cheveldayoff or Mr. Harrison may move this so that we can have him appointed. We'll do this just before orders of the day. So after I call orders of the day, somebody rises and with leave before orders of the day to move this.

Okay. I think that covers all the mechanics. Would someone move that the meeting adjourn? Ms. Heppner. All in favour?
