At page 19 and 20 – Members not seeking Re-election – Pay in the Lieu of Notice of termination be amended by omitting all the words after resignation and inserting

• "Previous receipt of a pay in lieu of notice payment as a constituency assistant.

A pay in lieu of notice payment was issued to constituency assistants at the dissolution of the previous Legislature (October 2011). Therefore four weeks' pay in lieu of notice of termination is the maximum amount that will be provided to constituency assistants.

Payments are funded through Directive # 6.4 - Constituency Assistant Benefits. The Payroll and Benefits unit of the Legislative Assembly Service will process the pay in lieu of notice payment of termination for eligible constituency assistants.

In those instances where a constituency assistant is employed by multiple Members, and one of the Members is not standing for election, the constituency assistant shall not be eligible to receive transition allowance or pay in lieu of notice of termination. The constituency assistant may receive pay in lieu of notice of layoff based on the ongoing employment relationship with the MLA(s) employer(s)."
