**ITEM 9: Discussion and Decision Item:** "Recruitment process for the Position of Ombudsman and Public Interest Disclosure Commissioner."

That an open competition be authorized for the position of Ombudsman and Public Interest Disclosure Commissioner, and further,

That the competition shall be conducted as follows:

- 1. That a budget of \$25,000 be authorized;
- 2. That a subcommittee of the Board of Internal Economy (Board) to be chaired by the Speaker and consisting of a Government Member of the Board, and an Opposition Member of the Board, be established as the selection panel;
- 3. That the Legislative Assembly Service provide Human Resource assistance to the selection panel;
- 4. That the selection panel recommend a preferred candidate or candidates, to the Board for consideration:
- 5. That the name of the candidate approved by the Board be transmitted to the Legislative Assembly by the Speaker.
