Procedural Clerk (Ms. Humble-Selinger): — Good morning everyone. Welcome to the Standing Committee on Crown and Central Agencies. The Acting Chair (Mr. Steele): — That concludes our business today. I'd ask a member to move the motion of adjournment. Mr. Grewal has moved. All agreed?

Some Hon. Members: — Agreed.
