The following words be added after the last word of the motion by Ms. Atkinson "but that in this recommendation, this committee not preclude any change in ownership structure of these Crowns, including joint ventures, if such structures can be proven to provide the best way of ensuring customer service, jobs, economic activity, and revenue to the province."

A recorded vote having been requested, the amendment to the motion was defeated as follows: AYES: 4, NAYS: 5.

A recorded vote having been requested, the main motion was carried unanimously as follows: AYES: 9, NAYS: 0.

7. It was moved by Mr. Wall:

That this Committee do now adjourn.
