That the Standing Committee on Crown and Central Agencies summon Mr. Fred Zinghan of the law firm Olive Waller Zinghan & Waller, and any other lawyers of that law firm, as well as any previous lawyers and or law firms related to Spudco and the subsequent law suit to answer questions and provide evidence required by this committee.

A debate arising, it was moved by Mr. Yates:

That this debate be now adjourned.

11. It was moved by Mr. Elhard:

That the Standing Committee on Crown and Central Agencies call Fred Zinkhan of the law firm Olive Waller Zinkhan & Waller to appear before the committee to answer questions with regard to the Spudco law suit.

The Chair ruled the proposed motion of Mr. Elhard out of order because it was the same question as another motion currently before the committee.

12. It was moved by Mr. Elhard:

That the Standing Committee on Crown and Central Agencies recommend to the Legislature that a full and independent public inquiry pursuant to *The Public Inquiries Act* be held into the actions of the government with regard to the failure of Spudco that resulted in the loss of \$28 million dollars and subsequently the payment of an additional \$7.9 million to settle a law suit related to the Spudco affair.

A debate arising, it was moved by Mr. Yates:

That this debate be now adjourned.

- 13. The Committee initiated its consideration of the annual report and related documents of Investment Saskatchewan for the year ending December 31, 2003.
- 14. Mr. Montgomery and Mr. Martens provided an overview of the Provincial Auditor's review of the annual reports and financial statements.
