To the Honourable Members of the Legislative Assembly:

HONOURABLE MEMBERS:

I have the pleasure to present the sixth report of the Standing Committee on Crown and Central Agencies for the twenty-ninth legislature. The committee is authorized by the Assembly to examine matters related to the Crown Investments Corporation of Saskatchewan and its subsidiaries, central government agencies, liquor, gaming, and all other revenue-related agencies and entities. The Assembly also periodically refers the regulations and bylaws of professional associations to the committee for review. Reports of the Provincial Auditor related to Crown Investments Corporation of Saskatchewan and its subsidiaries are permanently committed to the committee.

This report details the work of the Standing Committee on Crown and Central Agencies for the period November 17, 2021 to March 21, 2023. During this time, the committee reviewed 24 reports and financial statements released by Crown corporations and related entities and reviewed six chapters in two Provincial Auditor report volumes. The committee also made a number of decisions based on recommendations put forward by the Provincial Auditor. Additionally, the committee passed a motion requiring that status updates in regard to Provincial Auditor recommendations be provided to the committee three business days prior to a CCA meeting rather than 48 hours prior, and that the CCA *Status Update Guide for Officials* be updated to reflect this change in process.

Introduction

The Standing Committee on Crown and Central Agencies considers matters pertaining to Crown Investments Corporation of Saskatchewan (CIC) and its subsidiaries, central government agencies, liquor, gaming, and all other revenue-related agencies and entities. Annual reports and financial statements, and reports of the Provincial Auditor related to CIC and its subsidiaries are permanently committed to the Standing Committee on Crown and Central Agencies for review. This report focuses primarily on the committee's scrutiny role in its review of annual reports, financial statements, and Provincial Auditor reports for the period November 17, 2021 to March 21, 2023.

Committee Membership

The work of the committee would not have been possible without the service of its members. On November 17, 2021, the membership of the committee was comprised of Terry Dennis, Chair; Erika Ritchie, Deputy Chair; Steven Bonk; Daryl Harrison; Terry Jenson; Greg Lawrence; and Dana Skoropad.

On June 21, 2022, the Standing Committee on House Services passed the following motion to change the membership of the Standing Committee on Crown and Central Agencies:

That the names of Fred Bradshaw, Ken Cheveldayoff, Mark Docherty, and Doug Steele be substituted for the names of Terry Dennis, Daryl Harrison, Terry Jenson, and Dana Skoropad on the Standing Committee on Crown and Central Agencies.

On the same day, the Standing Committee on Crown and Central Agencies met and elected Fred Bradshaw as Chair.

The Standing Committee on House Services again changed the membership of the Standing Committee on Crown and Central Agencies on November 1, 2022, substituting the name of Nathaniel Teed for Erika Ritchie. The Standing Committee on Crown and Central Agencies met on the same day to elect a Deputy Chair. As Mr. Teed was the only opposition member on the committee, he was elected to preside as Deputy Chair pursuant to rule 123(2).

After the resignation of Mark Docherty as MLA on February 10, 2023, the Legislative Assembly adopted a motion that the name of Tim McLeod be added to the committee membership.

The current composition of the committee is Fred Bradshaw, Chair; Nathaniel Teed, Deputy Chair; Steven Bonk; Ken Cheveldayoff; Greg Lawrence; Tim McLeod; and Doug Steele.

Acknowledgments

The committee wishes to thank all members who participated in committee proceedings for their contributions, as well as staff from the Office of the Provincial Auditor, the Legislative Assembly Service, and the many witnesses who appeared before the committee. A list of officials and witnesses is attached to this report as an appendix.

Review of Reports and Financial Statements

The committee examines the reports and financial statements of all (CIC) Crown corporations, their subsidiaries, and revenue-related entities. Table 1 lists the reports and financial statements that have been considered and concluded by the committee since November 17, 2021. At this time, there are no outstanding reports or financial statements for the committee to consider.

Saskatchewan Opportunities Corporation (SOCO) was transferred to Innovation Saskatchewan effective April 1, 2022. As a result, the review of SOCO annual reports and financial statements is now under the purview of the Standing Committee on the Economy. An addendum to the 2020–21 SOCO report had been filed with the Standing Committee on Crown and Central Agencies prior to the transfer, and as the committee had already considered and concluded that annual report as a part of its business, the consideration and conclusion of the addendum was the final item of business from SOCO to be considered by the Standing Committee on Crown and Central Agencies.

Review of Provincial Auditor Reports

The Standing Committee on Crown and Central Agencies considered six chapters in two Provincial Auditor report volumes. It considered seven recommendations and concurred with them all, noted compliance with five recommendations, and noted progress towards compliance on two recommendations. The committee concluded consideration of five chapters that did not have any new recommendations.

Table 3 lists the Provincial Auditor report chapters committed to the committee and currently awaiting committee consideration. The tables are followed by the details of decisions made by the committee, based on its review of the chapters listed in Table 2.

More Detailed Analysis and Planning For Cybersecurity Risks Needed

The committee concurred with recommendation 1 made at page 134 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation maintain well-defined action plans clearly addressing all significant risks of cyberattacks that may affect IT systems and data used to support and deliver casino games.

The committee noted that Saskatchewan Gaming Corporation has complied with the recommendation.

Stronger Network and IT Device Controls Needed to Restrict Access

The committee concurred with recommendation 2 made at page 136 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation adequately configure its network, servers, and workstations to better protect them from security threats and vulnerabilities.

The committee noted that Saskatchewan Gaming Corporation is making progress towards complying with the recommendation.

User Access Review and Password Requirements Need Strengthening

The committee concurred with recommendation 3 made at page 137 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation include all privileged-user groups in its quarterly user access reviews.

The committee noted that Saskatchewan Gaming Corporation has complied with the recommendation.

The committee concurred with recommendation 4 made at page 137 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation update all user account passwords as often as required by its password policy.

The committee noted that Saskatchewan Gaming Corporation has complied with the recommendation.

The committee concurred with recommendation 5 made at page 137 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation implement further use of multifactor authentication to reduce, to an acceptable level, the risk of unauthorized access to IT systems and data.

The committee noted that Saskatchewan Gaming Corporation is making progress towards complying with the recommendation.

Security Assessments and Analysis Need Improvement

The committee concurred with recommendation 6 made at page 140 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation update its IT security assessment plan to reflect changes in its practice and to align with IT industry standards.

The committee noted that Saskatchewan Gaming Corporation has complied with the recommendation.

The committee concurred with recommendation 7 made at page 140 of the Provincial Auditor's 2021 report volume 2, chapter 17, Saskatchewan Gaming Corporation — Preventing Cyberattacks:

We recommend Saskatchewan Gaming Corporation analyze information from security assessments and attempted cyberattacks to better identify and address cybersecurity risks.

The committee noted that Saskatchewan Gaming Corporation has complied with the recommendation.

Status Updates

Prior to committee consideration of Provincial Auditor report chapters, Crown corporations and subsidiaries are required to submit updates to the committee, through CIC, describing the implementation status of the Provincial Auditor's recommendations. Information required includes any actions planned or taken and progress made towards implementing the recommendations, as well as the timeline for completion. The status updates allow committee members to familiarize themselves with the work completed to date so they may better formulate questions to ask during committee proceedings.

Since this requirement was adopted in 2019, the deadline for the submission of status updates had been 48 hours prior to a committee meeting. However, if that 48-hour period fell over the course of a weekend, committee members did not have sufficient time to review the status updates prior to the meeting. On October 19, 2022, the Standing Committee on Public Accounts changed its status update deadline requirement to three business days rather than 48 hours. Accordingly, on December 13, 2022, the Standing Committee on Crown and Central Agencies passed the following motion:

That status updates be provided to the committee three business days prior to a CCA meeting; and further.

That the CCA Status Update Guide for Officials be updated to reflect this change in process.

The CCA Status Update Guide for Officials has accordingly been updated, and a copy was provided to CIC.
