  - **Minor issue:** Subclause 15-31, reads “stockpile” means a pile or heap of ore, coal or waste at a mine ...” they used the word “or” but should be “of”.
  - Letter sent September 12, 2019 to Minister of Justice
  - Response received November 4, 2019 from Legislative Drafting Branch
  - **Disposition :** Awaiting next amendment of the Regulations to make corrections.
