**Re: Unauthorized and Illegal Colonial Sale of KFN Treaty Lands**

Further to my recent letter of October 26, 2021, I write to you on behalf of the KFN Nation to put the Crown on notice that its planned sale of Crown Land: Location: SE19-17-04 titled acres 152 usage grazing lands at McDougall On-Line Action Sales is illegal and unauthorized by the KFN Nation.

The Crown has fiduciary obligations to us through our Treaty and has not consulted us on this sale of lands.

We live in a country which espouses adherence to UNDRIP and Reconciliation, and yet here the KFN Nation finds itself at the hands of the ongoing colonial practice of land dispossession without consent or benefit.

The Crown does not have the KFN Nation's Free, Prior, and Informed consent to sell its Treaty lands.

The government of Saskatchewan is put on notice to immediately stop any and all sales of Crown lands in our traditional territory, as more particularly set out in **Schedule A** to this letter.

The KFN Nation is contacting the media about this ongoing colonial theft of our lands, and we will be telling the world about these practices which are illegal and completely out of step with modern norms of Reconciliation.
