7. The Committee adopted the following resolutions for the Legislative Branch of Government:

Supplementary Estimates 2000-2001

- i) Resolved, that towards making good the supply granted to Her Majesty on account of certain charges and expenses of the public service for the fiscal year ending March 31, 2001, the sum of seventy-one thousand dollars be granted out of the General Revenue Fund. (Yates)

Main Estimates: Less Interim Supply No.1

- ii) Resolved, that towards making good the supply granted to Her Majesty on account of certain charges and expenses of the public service for the fiscal year ending March 31, 2002, the sum of eleven million, six-hundred fifty-eight thousand dollars be granted out of the General Revenue Fund. (Harper)
