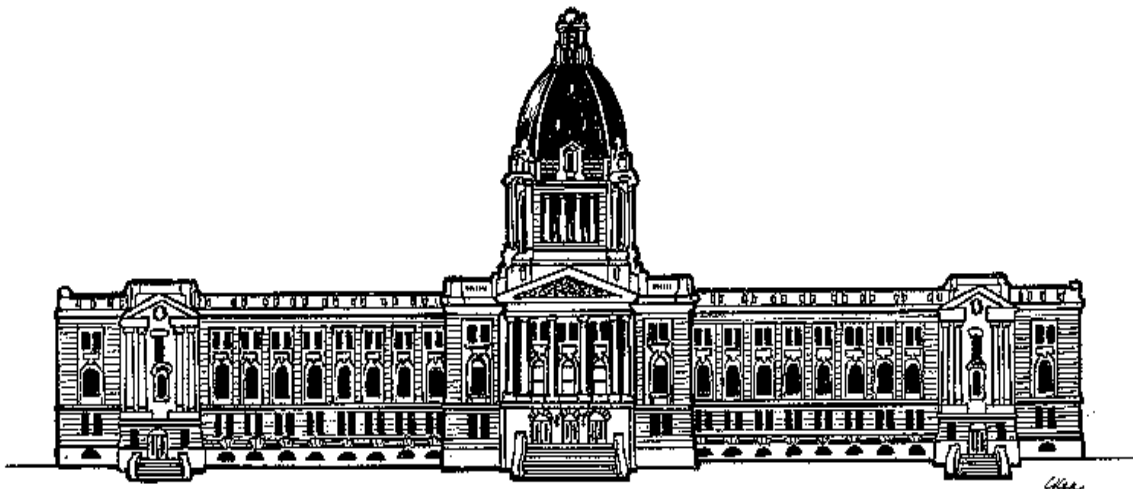

**The Deputy Chair:** — The legislative branch of government, the estimates referred to us deals with the Children's Advocate (CA01), the Children's Advocate operations in the estimates listed at \$200,000. Is it agreed?

**Some Hon. Members:** — Agreed.

**The Deputy Chair:** — We are carried on that particular motion. I will take a moment here just to sign that off in the book. I ask a member to move the following motion:

Resolved that there be granted to Her Majesty for the 12 months ending March 31, 2008 the following sums, for the Children's Advocate, \$200,000.

**Mr. Weekes:** — I so move.

**The Deputy Chair:** — Moved by Mr. Weekes. Is that agreed?

**Some Hon. Members:** — Agreed.

**The Deputy Chair:** — Carried.

[Vote 76 agreed to.]

**The Deputy Chair:** — Now members have a copy of the committee's third report. I would ask Mr. Gantfoer to move a motion to adopt the report and present it to the Assembly.

**Hon. Mr. Gantfoer:** — Thank you, Mr. Chair. I move:

That the third report of the Standing Committee on House Services be adopted and presented to the Assembly.
