Vote 76**

The Deputy Chair: — Carried. Ombudsman and Public Interest Disclosure Commissioner, vote 56 — \$4,324,000. I will now ask a member to move the following resolution:

Resolved that there be granted to His Majesty for the 12 months ending March 31st, 2025, the following sums for Ombudsman and Public Interest Disclosure Commissioner in the amount of \$4,324,000.

The Deputy Chair: — Mr. Love. Is that agreed?

Vote 28**

The Deputy Chair: — Carried. Unforeseen expenses, subvote (PA02) in the amount of \$641,000, is that agreed?

The Deputy Chair: — Carried. Provincial Auditor, vote 28 — \$9,983,000. I will now ask a member to move the following resolution:

Resolved that there be granted to His Majesty for the 12 months ending March 31st, 2025, the following sums for Provincial Auditor in the amount of \$9,983,000.
