Bill No. 80 — The Construction Industry Labour Relations Amendment Act, 2009

The Chair: — Good morning, ladies and gentlemen. We're here in Human Services Committee to report Bill 80. Seeing as it's 9:35, it's 5 minutes past the agreed upon hour for this committee meeting, we have allowed ample time for all members to attend and we will now begin.

I will introduce members that are present here this morning. We have voting members Mr. Glen Hart, Ms. Doreen Eagles, Minister Jim Reiter, and Ms. Joceline Schriemer and myself. I'm Greg Ottenbreit, the Chair. No other committee members are present.

Pursuant to the rule 34(d), the rules provide that on the day before completion day the committee may meet without quorum; however, quorum is present.

The business before the committee is Bill No. 80, *The Construction Industry Labour Relations Amendment Act*, 2009.

Today is the day prior to completion day, therefore the rules order the committee to complete its business. The Bill will now be considered in accordance with rule 34(2) and rule 35 which read as follows:

34(2) In any case where a specified bill has not been reported by a standing committee before 9:00 a.m. on the day prior to Completion Day, the committee shall convene to conclude examination of the bill as follows:

(a) The Chair will put the question on any amendments, new clauses or new schedules that had been previously proposed before putting a combined question, if required, in order to conclude examination of the bill.

And according to Rule 35(a):

Each specified bill introduced during the fall period of sittings or before December 21st during the first session of a new Legislature is subject to no less than 20 hours of debate.

These conditions have been met. Bill No. 80, *The Construction Industry Labour Relations Amendment Act, 2009*, has just over 24 hours of debate in this committee.

The committee will now proceed to the combined question on all clauses of the Bill.

Are clauses 1 through 24 agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried.

[Clauses 1 to 24 inclusive agreed to.]

The Chair: — Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan enacts as follows:

The Construction Industry Labour Relations Amendment Act, 2009. The examination of Bill 80 is now complete. I will now entertain a motion to report the Bill without amendment. I recognize Mr. Hart.

Mr. Hart: — Mr. Chair, I move that Bill No. 80, *The Construction Industry Labour Relations Amendment Act*, 2009 be reported without amendment.

The Chair: — Committee members, Mr. Hart has moved that Bill No. 80, *The Construction Industry Labour Relations Amendment Act, 2009* has been reported without amendment. Is it the pleasure of the committee to adopt the motion?

Some Hon. Members: — Agreed.

The Chair: — Carried.

An Hon. Member: — *Nemine contradicente*.

The Chair: — *Nemine contradicente*. In accordance with rule 34, this committee now stands adjourned.
