The Chair: — Well good afternoon. Welcome to the Standing Committee on Human Services. My name is Ken Cheveldayoff. I'm the MLA [Member of the Legislative Assembly] for Saskatoon Willowgrove, and I will serve as your Chair this afternoon.

Committee members present and any substitutions: Ms. Meara Conway is a member, substituting in for her is Aleana Young today. Mr. Ryan Domotor is here, Mr. Muhammad Fiaz, Mr. Derek Meyers, Mr. Hugh Nerlien. Ms. Alana Ross is a member of the committee, and substituting in for her today is Mr. Travis Keisig.

Consideration of committee resolutions. We're here today to vote off the remaining committee resolutions for the following ministries in the 2022-23 year estimates. We'll be voting vote 37, 169, Advanced Education; vote 5, Education; vote 32, Health; vote 20, Labour Relations and Workplace Safety; vote 36, Social Services.

And in the 2021-22 supplementary estimates no. 2, we will be voting off vote 32 for Health.

General Revenue Fund Advanced Education Vote 37

The Chair: — We will begin with vote 37, Advanced Education. Central management and services, subvote (AE01) in the amount of 16,621,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Post-secondary education, subvote (AE02) in the amount of \$684,066,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Student supports, subvote (AE03) in the amount of \$39,200,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Non-appropriated expense adjustment in the amount of \$400,000. Non-appropriated expense adjustments are non-cash adjustments presented for information purposes only. No amount is to be voted.

So Advanced Education, vote 37 — 739,887,000. I will now ask a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Advanced Education in the amount of \$739,887,000.

Mr. Fiaz. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried.

General Revenue Fund Education Vote 5

The Chair: — All right. Vote no. 5, Education, on page 35. Central management and services, subvote (ED01) in the amount of 14,233,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. K to 12 education, subvote (ED03) in the amount of \$2,117,017,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Teachers' pensions and benefits, subvote (ED04) in the amount of 23,934,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Early years, subvote (ED08) in the amount of \$314,129,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Provincial library and literacy, subvote (ED15) in the amount of \$14,446,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Non-appropriated expense adjustment in the amount of zero dollars. Non-appropriated expense adjustments are non-cash adjustments presented for information purposes only. No amount is to be voted.

Education, vote 5 — \$2,483,759,000. I will now ask a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Education in the amount of \$2,483,759,000.

Mr. Domotor: — Yeah.

The Chair: — Mr. Domotor. Is that agreed?

Some Hon. Members: — Agreed.

General Revenue Fund Health Vote 32

The Chair: — All right. For vote no. 32, Health, on page 67. Central management and services, subvote (HE01) in the amount of \$10,110,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Saskatchewan health services, subvote (HE03) in the amount of 4,648,300,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Provincial health services and support, subvote (HE04) in the amount of 280,447,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Medical services and medical education programs, subvote (HE06) in the amount of \$1,047,938,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Drug plan and extended benefits, subvote (HE08) in the amount of 451,472,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Non-appropriated expense adjustment in the amount of \$1,501,000. Non-appropriated expense adjustments are non-cash adjustments presented for information purposes only. No amount is to be voted.

Health vote 32, in the amount of 6,438,267,000, is that agreed?

Resolved that it be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Health in the amount of \$6,438,267,000.

Mr. Nerlien. Is that agreed?

General Revenue Fund Labour Relations and Workplace Safety Vote 20

The Chair: — We'll now turn our attention to vote 20, Labour Relations and Workplace Safety, on page 91. Central management and services, subvote (LR01) in the amount of \$5,160,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Occupational health and safety, subvote (LR02) in the amount of \$9,935,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Employment standards, subvote (LR03) in the amount of \$3,171,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Labour Relations Board, subvote (LR04) in the amount of \$1,000,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Labour relations and mediation, subvote (LR05) in the amount of \$745,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Workers' Advocate, subvote (LR06) in the amount of \$863,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Non-appropriated expense adjustment in the amount of \$92,000. Non-appropriated expense adjustments are non-cash adjustments presented for information purposes only. No amount is to be voted.

Labour Relations and Workplace Safety, vote 20 — \$20,874,000. I will now ask that a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Labour Relations and Workplace Safety in the amount of \$20,874,000.

Mr. Meyers. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried.

General Revenue Fund Lending and Investing Activities Advanced Education Vote 169

The Chair: — Vote 169, Advanced Education on page 152. Loans to Student Aid Fund, subvote (AE01) in the amount of \$80,000,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried.

Advanced Education, vote 169 — \$80,000,000. I will now ask a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2023, the following sums for Advanced Education in the amount of \$80,000,000.

Mr. Keisig?

Mr. Keisig: — I do so move, Mr. Chair.

The Chair: — Making sure you're paying attention.

Mr. Keisig: — I'm paying very close attention, Mr. Chair. I'd just be a little bit uncomfortable moving \$80,000,000 worth of

funding not having had an opportunity to read the financials in detail, but I do so move. Thank you, Mr. Chair.

The Chair: — Mr. Keisig moves. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried.

General Revenue Fund Supplementary Estimates — No. 2 Health Vote 32

The Chair: — All right, and we'll go to supplementary estimates no. 2 from the 2021-22, vote 32, Health, on page 11. Saskatchewan health services, subvote (HE03) in the amount of \$112,751,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. Health, vote 32 — \$112,751,000. I will now ask a member to move the following resolution:

Resolved that there be granted to Her Majesty for the 12 months ending March 31st, 2022, the following sums for Health in the amount of \$112,751,000.

Mr. Nerlien. Is that agreed?

Some Hon. Members: — Agreed.
