To whom it may concern:

1. All provinces with the exception of Saskatchewan have a registry for the intended donor. Not all of them are optimized for access on line or by the clinical staff in hospitals.
2. They operate differently in each province either attached to the health care card or the drivers licence.
3. They do not tie into the national recipient registry. At some point in the future we could explore linkages of all registries with the national program. This is not seen as a high priority activity.
4. The national registry or the Canadian Transplant registry is for actual donor referrals to link with patients waiting on the list. It will be fully optimized and service all organ donation and transplantation activity. Briefs most recently sent should further inform the questions.
