STANDING COMMITTEE ON INTERGOVERNMENTAL AFFAIRS AND INFRASTRUCTURE December 4, 2006

General Revenue Fund Supplementary Estimates — November First Nations and Métis Relations Vote 25

The Chair: — And the first item on the agenda is the consideration of the supplementary estimates for the Department of First Nations and Métis Relations which can be found on page 14 in the Supplementary Estimates — November book, and that would be vote 25. Are there any questions? Not seeing any questions, is the committee ready to consider the estimates? Seeing a nod from the opposition, yes.

The first item of business then would be in vote 25, the central management services (FN01) for 100,000,000. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — (FN02) for 350,000,000. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Pardon me — 350,000. In thousands. I'm sorry. Sorry. I thought it was in millions. The gaming agreement (FN03), 11,037,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — For a total of 11,484,000, is that agreed?

Some Hon. Members: — Agreed.

Resolved that it be granted to Her Majesty for the 12 months ending in March 31, 2007, the following sums for First Nations and Métis Relations, 11,487,000.

General Revenue Fund Supplementary Estimates — November Government Relations Vote 30

Not seeing any questions, is the committee ready to deal with the estimates? That would be in vote 30 (GR10), for 13,965,000. Is that agreed?

General Revenue Fund Supplementary Estimates — November Highways and Transportation Vote 16

The Chair: — The next item of business before the committee is the consideration of supplementary estimates for the Department of Highways and Transportation, and that can be found on page 16 in the Supplementary Estimates — November book, and that's Highways and Transportation, vote 16. Any questions? Not seeing any questions, the committee will address the estimates.

For (HI10) 600,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — (HI04) for a total of 22,030,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — For the Department of Highways and Transportation vote 16, total amount of 22,630,000, is that agreed?

Some Hon. Members: — Agreed.

Resolved that there be granted to Her Majesty for the twelve months ending March 31, 2007, the following sums for Highways and Transportation, 22,630,000.

Is that agreed?

General Revenue Fund Supplementary Estimates — November Highways and Transportation Capital Vote 17

The Chair: — The next estimates to be considered is under the Department of Highways and Transportation capital vote 17 which can be found on page 16 of your Supplementary Estimates — November book.

And that would be (HC01) for \$9,900,000. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Infrastructure enhancements, (HC02) for \$22,100,000, is that agreed?

Some Hon. Members: — Agreed.

The Chair: — That's a total for the Department of Highways and Transportation capital of 32,000,000. Is that agreed?

Resolved that there be granted to Her Majesty for the 12 months ending March 31, 2007, the following sums which to the extent they remain unexpended for the fiscal year are also granted to the fiscal year ending March 31, 2008, and that's for the Highways and Transportation capital, 32,000,000.

General Revenue Fund Supplementary Estimates - November Justice Vote 3

Resolved that there be granted to Her Majesty for the 12 months ending March 31, 2007, the following sums for Justice, 3,833,000.
