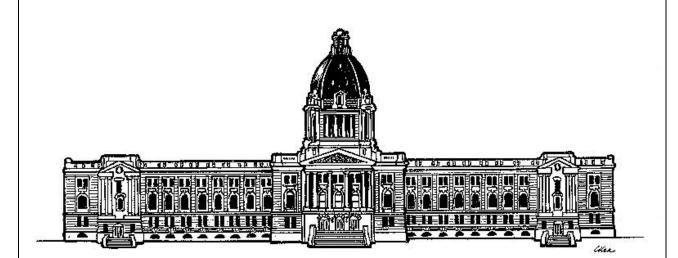

Procedural Clerk (Ms. Humble-Selinger): — Good morning everyone. Welcome to the Standing Committee on Intergovernmental Affairs and Justice. My name is Danielle Humble-Selinger and I'm the Clerk overseeing the committee this morning. It is my duty as committee Clerk to preside over the election of a new Chair. I'd like to remind members of the process. I will first ask for nominations. Once there are no further nominations, I will then ask a member to move a motion to have a committee member preside as Chair. I will now call for nominations for that position. Mr. Steele.

Mr. Steele: — I nominate Mr. Terry Dennis to the position of Chair.

Procedural Clerk (Ms. Humble-Selinger): — Mr. Steele has nominated Mr. Terry Dennis to the position of Chair. Are there any further nominations? Seeing none, I would now invite one of the members to move the motion.

Mr. Steele: — I move:

That Mr. Terry Dennis preside as Chair of the Standing Committee of Intergovernmental Affairs and Justice.

Procedural Clerk (Ms. Humble-Selinger): — It has been moved by Mr. Steele:

That Mr. Terry Dennis preside as Chair of the Standing Committee on Intergovernmental Affairs and Justice.

All in favour of the motion?

Some Hon. Members: — Agreed.

Procedural Clerk (Ms. Humble-Selinger): — All those opposed? I declare the motion carried and invite Mr. Dennis to take the Chair.

The Chair: — Good morning. That concludes our business today. I would ask a member to move a motion of adjournment.

Mr. Grewal: — I move the motion of adjournment.

The Chair: — Mr. Grewal has moved. Is that agreed?

Some Hon. Members: — Agreed.

The Chair: — Carried. The committee stands adjourned until the call of the Chair.
