Issues being monitored for changes/corrections:

- ***The Securities Commission (Adoption of National Instruments) (NI 31-103 and NI 33-109 Amendment Regulations, 2017***
 - **Issue:** Regulation numbering of sections jumps from 5(c) to 7 with section 6 missing. Not clear if intentional or section 6 was to be repealed.
 - **Issue:** Subsection 13.7(1)(a), “account statements” is struck out and then inserted back. Assume it should be “account statements” is struck and substitute “additional statements”, which would be consistent with other amendments. &
 - Letter sent October 28, 2019 to the Minister of Justice
 - Response received November 10, 2019 from the Minister of Justice
 - **Disposition:** Awaiting next amendment of the Regulations to make the corrections that were suggested.
