

78 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: Mr. Weighill had made 44 recommendations for that office in 2018. Can you give an update on whether all of those recommendations have been implemented? And if not, which ones are outstanding? Could you just commit to tabling the ones that are outstanding for the record instead of going through them all that are outstanding? Could you also provide a timeline for the outstanding ones for when they are intended to be implemented?

Answer

80 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: Could you tell me who participates on the elders forum that you had just mentioned?

Answer

We do not provide the names of the elders due to confidentiality. The elders are representative of the province.

80 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: The Kimberly Squirrel review, is that just with the Ministry of Corrections or is the Ministry of Justice participating in that as well? I was hoping for a timeline for when that would be concluded.

Answer

The terms of reference were signed off by both Minister Tell and Minister Wyant. The investigation is nearing completion.

81 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: The individuals who answer 211 calls, so the 211 employees, have they received trauma-informed training? Could you, Minister, agree to provide the committee a copy of that contract?

Answer

The contract with 211 stipulates that those answering the calls have received training in trauma informed care.

83 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: Has the ministry kept track or able to keep track of how many requests have been made since Clare's Law has been implemented to access that information? Are you able to share what centres those 10 requests were made?

Answer

We are not able to share what centres the requests were made in due to confidentiality and privacy reasons.

85 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: Can you provide an update on the recommendations made from the last domestic violence death review panel?

Answer

We have made progress on all of the recommendations.

Most recently in the area of Awareness and Education we:

• Have launched a public awareness campaign, delivered by Phoenix Group. The campaign was translated into Cree, Dene, and French.

In the area of Intervention we:

- Have entered into a multi-year agreement with United Way Regina to enhance 211 Saskatchewan
- Are developing a transportation program to support individuals and their children fleeing violence.
- Have created a Family Intervention Rapid Support Teams (FIRST) established in Kindersley

87 -- Ms. Sarauer asked the Ministry the following question, which was answered by the Hon. Gordon Wyant:

To the Minister of Justice and Attorney General: I have several questions, so if you want to just provide me the [Office of Residential Tenancies] data you have. But inquiries, hearings, if you have it either annually or monthly. I'd also like to know how those numbers compare to the year prior.

Answer

Statistics:

The Office of Residential Tenancies (ORT) has seen an increase from over 90,000 inquiries in 2019-20 to over 160,000 in 2020-21 as set out in Table 1.

During 2020-21, only about 55% of all Rent Arrears applications resulted in a writ of possession being issued, the remainder being resolved by early dispute resolution and hearing officer determination of just and equitable solutions.

Access to Justice

Access to Justice is a priority for the Office of Residential Tenancies (ORT). To ensure the public has direct access to the ORT, the following resources are available:

- a website providing information to the public on their legal rights and obligations, and ORT processes, with audio videos in over 20 languages, including ASL;
- a toll free inquiry line, available to all of Saskatchewan residents during regular business hours;
- a new toll free hearing hotline, available to all of Canada during regular business hours; and,
- an email inbox, available for clients to send inquiries at any time.

If clients don't have the ability to appear by telephone at a hearing each ORT office provides access to a telephone, computer and scanner by appointment.

Having both parties appear by the same method alleviates concerns about procedural fairness. The recent ORT performance audit conducted by the Provincial Auditor in the fall of 2020 did not find any access to justice or conflict of interest issues but found that attendance at hearings is being conducted appropriately, in line with good practice.

To the Minister of Justice and Attorney General: Could you commit to if there is a reduction in funding in any programs, to provide that information to the committee?

Answer

There has been no reduction in funding to programs.

To the Minister of Justice and Attorney General: Could you provide that information, some updated information about those wait times [in Legal Aid]?

Answer

The Average Wait Time is the number of calendar days between the date the applicant is declared eligible for Legal Aid and the date that the lawyer is first available to meet.


The Saskatchewan Legal Aid Commission (SLAC) has established a client service standard that states that 90% of clients will meet with a lawyer within three weeks of being declared eligible. This service standard is only applied to full-service clients.
