STANDING COMMITTEE ON PUBLIC ACCOUNTS March 7, 2011

[The committee met at 09:30.]

The Chair: — At this time we'll convene the Standing Committee on Public Accounts, and today we've got a couple of ... well I guess one consideration. Provincial Auditor Selection Process

Mr. Hart: — Thank you, Mr. Chair. Mr. Chair, I would make the following motion:

That pursuant to section 3.1(1) of *The Provincial Auditor Act*, the Standing Committee on Public Accounts unanimously recommends to the Legislative Assembly Bonnie Lysyk for the appointment to the position of Provincial Auditor of Saskatchewan.
